

In Space G, television broadcast station WGN was reported as being carried by the cable system. According to our reference sources, the satellite feed for broadcast station WGN changed to a program service (WGN America) starting November 2015. 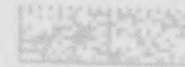

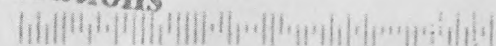
