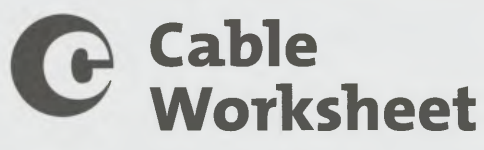

SECONDARY TRANSMISSION SERVICE: SUBSCRIBERS AND RATES

In General: The information in space E should cover all categories of secondary transmission service of the cable system, that is, the retransmission of television and radio broadcasts by your system to subscribers. SERVICES OTHER THAN SECONDARY TRANSMISSIONS: RATES

PRIMARY TRANSMITTERS: TELEVISION


