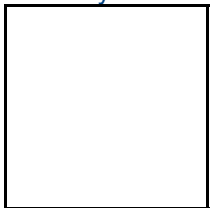

In Space D of the above referenced statement of account, 6 communities were listed (King George, Bowling Green, Colonial Beach, Uninc. Caroline County, Uninc. Westmoreland County and Westmoreland, VA.). In Space G, 7 different channel line ups were listed. In part 9 of the DSE schedule, 8 different groups were listed.
