Dear Petra O'Neill:

In Space Q, the cable system calculated a royalty payment of \$520.32. However, according to our system the interest payment should have been \$5.54. It seems this error is a result of a error made in Space Q, line 1. The amount of underpayment that should have been entered on this line is the minimum fee (\$8,784.83) and not the gross receipts. This error has resulted in an overpayment of \$514.78.

To request a refund, submit a corrected statement along with a completed EFT and email them directly to me. Please remember that Effective March 20, 2020 there is a \$50 amendment fee for any and all material changes. An EFT form is attached for your reference.
