It appears as if an overpayment has occurred on the above referenced statement of account. The correct royalty fee of \$2,990.82 (plus \$20 filing fee) was calculated, however \$3,062.82 was submitted. Based on the gross receipts reported, only block 3 of Space L should have been used. Please review.

Without a statutory license, a cable system could be sued by copyright owners for the full range of civil remedies for copyright infringement, including injunctions, actual damages and profits, or statutory damages (of up to \$150,000 in cases of willful infringement). The statute also provides for criminal penalties in cases of willful infringement for commercial purposes.
