Sorry about the delay at our end. While we were corresponding, a decision was made to change our refund procedures, and until they were finalized, I could not proceed. Now that I have revised the Statement again, it appears that there is a problem with the Wabasha subscriber group: WHLA is reported as distant, but appears to be local via its service contour, and KTCA is reported as local, but it appears to be distant, for the same reason. This change does not appear to change the royalty calculation, but it is an "obvious error or omission" that I am required to inquire about.

Would you please review this and revise the statement as necessary?
