SUBJ: REQUEST FOR PHOTO ON VINCENT JOHN CONNOLLY, DATA 40094

1. A 20 MAY 1974 LETTER FROM THE DEPARTMENT OF THE AIR FORCE INDICATED THAT A WIRE SERVICE PHOTOGRAPH RELEASED FROM WARSAW IN NOVEMBER 1966 SHOWED THE WRECKAGE OF A U.S. AIRCRAFT SHOT DOWN OVER NORTH VIETNAM. PHOTO INTERPRETERS DETERMINED IT TO BE THE WRECKAGE OF A F101C AIRCRAFT WHICH WAS PILOTED BY CAPT. VINCENT J. CONNOLLY, AN UNRESOLVED CASE. THIS DETERMINATION BY THE PHOTO INTERPRETERS WAS MADE BY THE IDENTIFICATION OF SEVERAL PARTS AS THOSE FROM A F-101 TYPE AIRCRAFT AND THE FACT THAT ALL BUT THE FIRST DIGIT OF CAPT CONNOLLY'S AIRCRAFT SERIAL NUMBER WAS VISIBLE IN THE PHOTOGRAPH.

2. REQUEST 8 X 10 PHOTO OF THIS AIRCRAFT WRECKAGE BE PROVIDED JCRC. PHOTO IS REQUIRED FOR PREPARATION OF A FOLDER TO BE PRESENTED TO SOCIALIST GOVERNMENTS OF SEASIA IN AN EFFORT TO NEGOTIATE THE RETURN OF THE REMAINS OF CAPT VINCENT J. CONNOLLY.
