2. ON 13 DEC 86, JCRC REP MR BELL INTERVIEWED
A GROUP OF APPROX 10 REFUGEES IN KHAO-I-DANG CAMP.
THE GROUP PROVIDED THE SAME NAMES AS THOSE IN
REF C AND REQUESTED RESETTLEMENT ASSISTANCE.
THE RESULTS OF THE INTERVIEW WERE FORWARDED AS
REF B. AN UNSIGNED LETTER CONTAINING THESE SAME
NAMES WAS RECEIVED BY JCRC LIAISON ON 25 NOV 86.
