INTERVIEW OF VIETNAMESE REFUGEE SC (NOTAL)

1. REF WAS REPORT OF INTERVIEW WITH SC AT SO CAMP RE-
GARDING HIS EXPERIENCES IN RE-EDUCATION CAMPS AND ESCAPING FROM
VIETNAM. SC, FORMER SDWAS SENT TO LONG THANH RE-EDUCATION CENTER NEAR THU
DUC IN JUN 75, MOVED TO QUANG NINH RE-EDUCATION CENTER NEAR THE
CHINESE BORDER IN OCT 76, AND MOVED TO THANH HOA NO. 5 RE-EDUCATION
CENTER IN AUG 78. HE WAS RELEASED FROM RE-EDUCATION IN JAN 80 AND
ESCAPED BY BOAT (NO NUMBER GIVEN) FROM CAMAU ON 12 APR 80, ARRIVING
AT SD ON 21 APR 80. HE AND HIS GROUP THEN ENTERED SD
CAMP ON 2 MAY 80, AND SC WAS APPOINTED CAMP LEADER AT SD.
REF DOES NOT SPECIFY WHEN SC ARRIVED AT SD. SC
BROTHER IS A FORMER LT COL WHO IS AT THE RE-EDUCATION CENTER AT HA
NAM NINH, AND SC CORRESPONDED WITH HIM BY MAIL.2. REQUEST YOU DETERMINE IF SC HAS ANY PW/MIA INFORMATION
BASED ON HIS OWN EXPERIENCES OR IF HIS BROTHER HAS MENTIONED ANY
AMERICANS IN HA NAM NINH (OTHER REFUGEES HAVE REPORTED AMERICANS AT
DAM DUN IN THIS PROVINCE). ALSO DETERMINE HIS BROTHER'S NAME, CAMP
LOCATION, PRESENT WHEREABOUTS AND ANY PLANS TO ENTER THE REFUGEE
STREAM UPON RELEASE.3. REF INDICATED SC IS INS APPROVED FOR RESETTLEMENT IN
THE U.S., WHERE HE HAS A SISTER. IF HE HAS DEPARTED CAMP, REQUEST
