1. Source/administrative data:

2. Summary: In a refugee interview screening conducted by Stony Beach personnel, Source provided identification media pertaining to one portion of alleged American remains currently in his possession.


3. Information: On 3 October 1991, Stony Beach debriefers screened Source at the *Source Data* in Arranyaprathet, Thailand. Source stated he possessed one portion of human remains and provided the following identification data:

ROBERT TAYLOR; RA *Data* A; PROT

4. Source did not furnish further details concerning his acquisition of the remains or their current location. Source also did not provide any information concerning the circumstances surrounding the alleged American's loss incident. Source requested 40,000 Thai baht from the American government in exchange for his relinquishing these remains to U.S. authorities.

5. Comments: Preliminary examination of JTF-FA records indicates the identification information of paragraph three, above, does not pertain to any known American unaccounted-for in Southeast Asia.
