4. THE FOLLOWING IS PROVIDED IN RESPONSE TO YOUR REQUEST IN
 REF E REGARDING "DICK JABER" AND "JIM MOORE."

4A. "DICK JABER" WAS AN AMCIT CIVILIAN RESIDENT OF VIENTIANE,
 LAOS. HE DID OPERATE A SMALL SHOP ON SAM SEN THAI STREET IN
 VIENTIANE AND MAY HAVE BEEN INVOLVED IN OTHER ACTIVITIES RELATING
 TO GENERATOR MAINTENANCE IN SUPPORT OF THE AMEMB VIENTIANE GENERAL
 SERVICES OFFICE PRIOR TO HIS DEATH. APPROXIMATELY THREE WEEKS
 AFTER THE LPDR TAKEOVER IN LAOS, HE WAS SHOT AND FATALEY WOUNDED AT

HOUSE WHERE HE RESIDED WITH HIS THAI WIFE. HE WAS STILL ALIVE WHEN EVACUATED FROM VIENTIANE AND WAS TO BE EVACUATED TO CLARK AFB, PHILIPPINES BUT DIED ENROUTE TO BANGKOK. HIS WIFE MAY HAVE BEEN ACCOMPANYING HIM WHEN HE DIED. SUBSEQUENT TO HIS DEATH THERE WERE AMEMB CABLES SURROUNDING THE INCIDENT WHICH THE CONSULAR AFFAIRS SECTION AT THE AMEMB BANGKOK, SHOULD BE ABLE TO RETRIEVE TO PINPOINT THE DISPOSITION OF HIS REMAINS FOLLOWING THEIR ARRIVAL IN BANGKOK.

4B. THE DEPARTMENT OF THE ARMY MEMORIAL AFFAIRS OFFICE RECORDS INDICATE THAT RICHARD A. JABER, U.S. CITIZEN, PASSPORT NUMBER Z1332247, DIED IN THAILAND ON 22 JULY 1975. THEY WILL BE REQUESTING HIS RECORDS FROM ARCHIVAL STORAGE, AND DIA WILL FORWARD DISPOSITION OF REMAINS DATA REFLECTED IN THE RECORDS WHEN THE RECORDS BECOME AVAILABLE.

4C. "JIM MOORE" IS AN AMCIT CIVILIAN LAST KNOWN TO BE IN BANGKOK, TH SEVERAL YEARS AGO. HE HAD BEEN A RESIDENT OF VIENTIANE, LAOS UNTIL THE TIME OF THE LPDR TAKEOVER AND WAS AN ACQUAINTANCE OF "DICK JABER". JIM MOORE OWNED OR LEASED A NUMBER OF HOUSES IN VIENTIANE WHICH WERE REFERRED TO BY THE U.S. COMMUNITY

AS "LEESVILLE" AND WHICH HE LEASED TO THE AMEMB VIENTIANE FOR USE AS EMBASSY EMPLOYEE RESIDENCES. JIM MOORE WAS ALSO ASSOCIATED WITH A "MR. KRUGER," VIENTIANE REPRESENTATIVE FOR NORTHWEST AIRLINES. BASED ON AVAILABLE DATA, JIM MOORE SHOULD BE APPROXIMATELY 65 YEARS OF AGE IF HE IS STILL ALIVE IN BANGKOK. JIM MOORE WAS WELL KNOWN TO A FORMER U.S. GOVERNMENT OFFICIAL, PAT LANDRY, CURRENTLY REPORTED RETIRED AND ALSO RESIDING IN BANGKOK.

4D. INFORMATION IN PARAGRAPHS 4A-B ABOVE OBTAINED FROM THREE INDIVIDUALS WHO PERSONALLY WERE ACQUAINTED WITH DICK JABER AND JIM MOORE. INFORMATION PERTAINING TO EVACUATION OF MR. JABER WAS OBTAINED FROM A FORMER AMEMB MEDICAL OFFICER IN VIENTIANE WHO WAS IN MANILA, RP AT THE TIME DICK JABER DIED. THIS MEDICAL OFFICER ALSO PERSONALLY OBSERVED AMEMB CABLES SURROUNDING THE REPORTS OF DICK JABER'S SHOOTING AND EVACUATION.
