Chapter 1.—COMPOSITION, ORGANIZATION, AND GOVERNMENT OF THE ARMY GENERALLY.

★ Section 5. Organization of Army; corps areas and army areas or departments.—

"tropps" in line 15 of this section should read "troops."

6. Appointment of chiefs and assistant chiefs; term of office.—* * * years' commissioned service. And provided further, That during the period of seven years immediately following July 1, 1926, any appointment as Chief of the Air Corps shall be made from among officers of any grade of not less than fifteen years' commissioned service, and from those who have demonstrated by actual and extended service in such corps that they are qualified for such appointment; and as assistants from among officers of not less than fifteen years' commissioned service of similar qualifications; Provided, That the Chief of the Air Corps shall make recommendations to the Secretary of War for the appointment of his assistants.

The statutory provision constituting § 6 of this title was amended by § 7 of Act July 2, 1926, c. 721, 44 Stat. 783, entitled "An Act to provide more effectively for the national defense by increasing the efficiency of the Air Corps of the Army of the United States, and for other purposes." The amendment added the two provisos set out above at the end of the section, beginning with the words "And provided further."

Chapter 2.—GENERAL STAFF CORPS.

Section 23a. Air section of War Departmen, .eraI Staff.—For the period of three years immediately following July 1, 1926, there is hereby created in each of the divisions of the War Department General Staff an air section to be headed by an officer of the Air Corps, the duties of which shall be to consider and recommend proper nation on such air matters as may be referred to such division.

New. This section constitutes § 5 of Act July 2, 1926, c. 721, 41 Stat. 782, entitled "An Act to provide more effectively for the national defense by increasing the efficiency of the Air Corps of the Army of the United States, and for other purposes."

26. General Staff Corps eligible list.—

After the completion of the initial General Staff Corps eligible list, the name of no officer shall be added thereto unless upon graduation from the General Staff School he is specifically recommended as qualified for General Staff duty, and hereafter no officer of the General Staff Corps, except the Chief of Staff, shall be assigned as a member of the War Department General Staff unless he is a graduate of the General Staff College or hls name is borne on the initial eligible list: Provided, That nothing herein shall operate to debar the name of any graduate of the Army War College, the Command and General Staff School, or the former General Staff College, General Staff School, Army Staff College, the Staff College, the School of the Line, the Army School of the Line, or the Infantry-Cavalry School from being added to the General Staff Corps eligible list if the manner of the performance of his duties and quality of his work is such as to indicate that he has since become well

qualified for General Staff duty, and he is so recommended by

a board of general officers: And provided further, That the

name of any National Guard or reserve officer who has demon-

strated by actual service with the War Department General Staff during a period of not less than six months, as hereinafter provided for, that he is qualified for General Staff duty, may, upon the recommendation of a board consisting of the general officers of the War Department General Staff, assistants to the Chief of Staff, be added to said eligible list at any time. The Secretary of War shall publish annually the list of officers eligible for General Staff duty, and such eligibility shall be noted in the annual Army Register.

The statutory provision constituting § 26 of this title was amended by Act May 21, 1928, c. 647, 45 Stat, 618, entitled "An Act to amend the second paragraph of section 5 of the National Defense Act, as amended by the Act of September 22, 1922, by adding thereto a provision that will authorize the names of certain graduates of the General Service Schools and of the Army War College, not at present eligible for selection to the General Staff Corps eligible list, to be added to that list."

The amendment affected that part of the section set out above.

30. Acting General Staff officers.-
