Chapter 1.—AMERICAN NATIONAL RED CROSS.

Section 12. Buildings for Red Cross supplies.—

Chapter 8.—AMERICAN BATTLE MONUMENTS COMMISSION.

Section 122. Expenses of Army officers serving on commission.—When traveling on business of the commission officers of the Army serving as members or as secretary of the commission may be reimbursed for expenses as provided for other members of the commission.

The statutory provision constituting § 122 of this title was superseded by a part of § 1 of the Executive, etc., Appropriation Act of Apr. 22, 1926, c. 171, 44 Stat. 307, set out in the text.

The provision as it appears in the text was repeated in § 1 of the Executive, etc., Appropriation Acts of Feb. 11, 1927, c. 104, 44 Stat. 1071, and May 16, 1928, c. 580, § 1, 45 Stat. 575.

133. Disbursing agent for disbursement of expenditures outside of United States.—

The statutory provision constituting § 133 of this title was repeated in the Executive, etc., Appropriation Acts of Apr. 22, 1926, c. 171, § 1, 44 Stat. 307, and Feb. 11, 1927, c. 104, § 1, 44 Stat. 1071.

134. Amount of obligations authorized.—The commission may incur obligations and enter into contracts for building materials and supplies and for construction work, which, inclusive of the amounts herein and heretofore made available, shall not exceed a total of \$3,000,000.

135. Power to contract for work in Europe.—Notwithstanding the requirements of existing laws or regulations and under such terms and conditions as the commission may in its discretion deem necessary and proper, the commission may contract for work in Europe, and engage, by contract or otherwise, the services of architects, firms of architects, and other technical and professional personnel.

136. Seal of Commission; judicial notice.—The commission shall have a seal, which shall be judicially noticed.

137. Disposition of land in foreign countries.—The commission may, under such terms and conditions and in such manner as the commission may in its discretion deem necessary and proper, dispose of any land or interest in land in foreign countries which has been or may hereafter be acquired by the commission in connection with its work.

Chapter 9.—MISCELLANEOUS.

Section 143. May first designated as Child Health Day.—The President of the United States is hereby authorized and requested to issue annually a proclamation setting apart May 1 of each year as Child Health Day and inviting all agencies and organizations interested in child welfare to unite upon that day in the observance of such exercises as will awaken the people of the Nation to the fundamental necessity of a year-round program for the protection and development of the health of the Nation's children.
