GOVERNOR COCHRAN'S ADDRESS.

The following is the full text of the inaugural address delivered by Governor Cochran at Dover, to-day.

FELLOW CITIZENS.—Having been elected Governor of the State of Delaware, and, in your presence, having taken the oath of office prescribed by the Constitution of the United States...

In assuming the duties of the high office I have received at the hands of my fellow citizens, I desire to make public acknowledgment of the obligations I feel for this gratifying proof of their confidence and regard.

By virtue of express provisions of the Constitution of Delaware, the supreme executive powers of the State are vested in the Governor.

This Constitutional power lies at the root of the Government, and should be exercised with the most careful discrimination and the view of selecting only honest, capable and judicious men to fill the office.

Public officers are created for the benefit of the people and not for selfish and individual ends.
