

ACCUSE THE COMMISSIONERS

Truesdell in Particular Scored At the Citizens' Mass-meeting.

HIS MOTIVE WAS QUESTIONED

Had Not Speeches Made in Protest Against Locating the Contagious Diseases Hospital at Mount Pleasant--Executive Committee Appointed to Fight the Scheme.

The citizens of Mount Pleasant, Columbia Heights, and Brightwood have not much to say for the District Commissioners. Since the announcement of the selection of a contagious diseases hospital site there has been a deal of ill-feeling among these citizens, and last night they held a meeting at the corner of Fourth street and Florida avenue to take some definite action.

The Commissioner's action was criticized in vigorous, unmistakable language by a number of prominent Washingtonians, and after a discussion of an hour and a half an executive committee was appointed and the following resolution adopted:

"Resolved, That the executive committee have full authority to represent citizens of this section before the District Commissioners and Congress, and also to take such legal steps as may be deemed necessary, and any other action which in their judgment may be necessary to prevent the erection of a contagious diseases hospital on the site recently selected."

More than 300 of the most prominent citizens of the city attended the meeting, among them Mrs. Gen. J. A. Logan, and the business of the evening was transacted in a prompt and systematic manner.

Permanent officers were then elected as follows: Chairman, J. W. Somerville; vice chairman, L. M. Saunders; secretary, J. M. Husted; assistant, C. E. King, and treasurer, C. G. Snyder. Messrs. G. B. Towles, F. C. Hasty, and C. L. Hicketts were appointed to nominate an executive committee to continue the struggle against the proposed site.
