TRADE-MARKS.

DECISION BY JUDGE HOOVER. Judge Hoover yesterday engaged in hearing the demurrer filed by Louis Heller to the bill of complaint filed against him by Willoughby, Hill & Co. This suit was commenced some time in the year 1913. The bill asks for an injunction to restrain the defendant from selling clothing under the name of "Square-Dealing Clothing" as a trade-mark, the complainants claiming the exclusive privilege of using those words. An accounting is also asked for to ascertain the damages resulting to complainants by this alleged wrongful act of the defendant in infringing upon their so-called trade-mark. Complainants assert their right to the exclusive use of those words by virtue of the fact that they were first used by them and that they were granted them by the Commissioner of Trade-Marks in April, 1912, under the law of July 8, 1910, on the subject of trade-marks.

To this bill the defendant interposed a general demurrer, claiming that the words in controversy were incapable of exclusive appropriation by the complainant; that the words "square-dealing" are in the public domain, but only in trade-marks as formed by the complainant.
