LETTER FROM MR. AMOS T. AKERMAN.

THE SOUTH.
I believe that the permanent good government and the prosperity of the South would be promoted by the continuance of the Republican administration at Washington. I believe that the election of a Democratic President this year would establish a Democratic party of the South the dominion of its worst men, would give heart to the lawless, would discourage the industrious and the enterprising, would raise into fierce and bitter strife that which is now quiet, and would set back a current of public opinion that is advancing, slowly but steadily, but permanently, toward permanent friendship between white and black and between North and South.

THE SOUTH.
Troubled as the South has been since the war, her condition has yet been infinitely better with a Democratic administration than it would have been with a Republican administration. With a Democratic Administration the evil dispositions which President Johnson and a Republican Congress have kept somewhat in check would have rioted with unrestrained freedom, and as long as that untoward feeling which in 1861 and 1862 moved the South to secession, and in 1867 moved the majority of her white citizens against reconstruction, is in any of its modifications, a force in the politics, the power of repression, which is in the hands of the Government of the United States, that Government should exert it to the utmost.
