GROWTH OF THE CATTLE TRADE.

INTERESTING STATISTICS OF EXPORTS ISSUED BY THE AGRICULTURAL DEPARTMENT. Washington, Oct. 31.—Secretary Morton, of the Department of Agriculture, furnished today the number of cattle exported to Great Britain in each year since 1874, together with the value of the exports. The statement shows that the United States sent into the United Kingdom only 125 head of cattle in 1874, while in 1893 the farms of this country have already furnished to Great Britain 36,731 head. The United States sent no fresh beef into England until 1877, when 9,279 pounds were sent, which returned to the farmer of this country \$4,525.23. But in 1893 this country has already shipped to the United Kingdom 1,934,282 pounds of fresh beef, which has been sold for \$16,939.81. Accordingly, the United States will be permitted to import lumber from Canada by the terms of the new tariff which will come into the United States.

A BIG ABILITY CASE DECIDED.

Washington, Oct. 31.—A dispatch from Norfolk, Va., says that Judge Hooper, of the United States Circuit Court, has decided one of the largest ability cases ever tried in that city. In 1891 the British steamship Plymouth and Victoria, the former loaded with cotton and the latter light, were in collision in the lower harbor of Norfolk. The Plymouth was sunk and damaged to the extent of about \$100,000, and her cargo damaged about \$50,000.
