# ARMY AND NAVY

WASHINGTON, D. C., Nov. 1.—Col. Charles Page Bryan, ambassador from the United States to Japan, will reach Washington the latter part of this week on his first visit to the United States in four years. Colonel Bryan will be accompanied by his staff and secretary, Page Bryan, he is now in Paris.

He remained in Tokyo during the summer when Emperor Meiji was ill and was the last of the diplomats resident there to converse with the monarch. Recently the Dowager Empress sent the ambassador her autograph picture together with a photograph of the late Emperor.

Mrs. E. H. McCalla, widow of Rear Admiral McCalla, U. S. N., has bought the three-story brick residence at 2212 R street northwest. The price was between \$50,000 and \$55,000.

The residence is one of the handsomest in the neighborhood around Sheridan circle. It fronts fifty feet on R street and extends back eighty feet to an alley. It was built about six years ago by John D. Patton, who has occupied it since its completion and is now about to complete the erection of a new residence at Twenty-third street and Bancroft place northwest.

The R street house contains twenty rooms. The finishings are of mahogany and white enamel. The interior is admirably constructed for entertaining purposes, the entire first floor being taken up by a spacious salok, a drawing room, library, dining room and cloak room. The building is in the Colonial style of architecture.

The sale was made through the office of Francis Bennett Poe.

Judge Advocate General E. H. Crowder in his first annual report as law officer of the army, favors a plan whereby deserters from the army would be given an opportunity to redeem themselves in detention barracks.

Gen. Crowder says a study of desertion statistics shows that many of courts-martial and reviewing authorities believe that dishonorable discharge is the proper punishment for nine-tenths of the deserters.

"My own opinion," Gen. Crowder continues, "is that a proportion of those discharged for desertion would redeem themselves if given the opportunity; just how large cannot be determined until the experiment is tried. If Congress passes the desired legislation to enable the War Department to establish detention barracks an opportunity will be given to determine the fact and shape our future policy on the fact and not on indefinite opinion.

There were 4,185 trials by court-martial during the past fiscal year, including twenty-nine officers and ten cadets at the Military Academy. The number of trials of enlisted men during the year was 5.5 per cent of their

average enlisted strength, an increase of 2 over the preceding year. In 1907 the percentage of trials was 6, in 1908 it was 6.2, in 1909 it was 7.4 and in 1910 it was 6.98. The total number of summary court trials during the past year was 37,412. The number of trials by summary court this year was 45 per cent of the average enlisted strength of the army, as against 43 per cent in 1911, 57 per cent in 1910, 64 per cent in 1909 and 69 per cent in 1908.

"The fact," says Judge Advocate General Crowder, "that there has been a rapid reduction in trials since 1908, and that the percentage has remained for two consecutive years under 50 per cent indicates that the service is relying more upon the authorized company discipline.

"No suggestion, official or otherwise, has reached this office that the discipline of the army has suffered in consequence. It is my opinion that the number of such trials could be still further reduced without impairing discipline, and it is quite certain that if enlarged powers of company discipline were placed in the hands of company commanders the number of summary court martials would at once decidedly diminish.

"With this in view it has been provided in the new articles of war, now under consideration by Congress, that under such regulations as the President may prescribe the commanding officer of any detachment, company or higher command may for minor offenses not denied by the accused and without the intervention of a court-martial impose disciplinary punishment including admonition, reprimand, withholding privileges, extra fatigue and restriction to certain specified limits, but not consisting of forfeiture of pay or confinement under guard."

Revised orders governing the movement and order of submarines in the United States Navy have been posted, providing that submarines will not operate singly but rather without notifying officers of the flotilla of the exact movements intended, and that vessels of the old type shall not go more than sixty feet under water or the new type more than 100 feet except under extraordinary conditions which are to be reported in detail.

It is possible that the Panama canal will fix a limit for the size of battleships, which, ever since steel war vessels were first made, have been steadily growing in size and cost. The Panama canal is 110 feet wide. At least five feet clearance is required on each side of a vessel, limiting the beam of ships using the canal to 100 feet.

proper beam of the vessel, according to English traditions or never exceeded to more than 100 feet. According to information that has reached the Navy Department, the English naval experts have decided to cut down the width of the new craft to less than 100 feet.

cruiser Baltimore, which has been ordered to duty as receiving ship at Philadelphia.

For many years past the Hartford had been used at Annapolis for instruction of the midshipmen in practical seamanship, but has almost recently taken by the cruiser Reina Mercedes, the Spanish war prize. This may be the last voyage of the Hartford, as it is expected that she will be dismantled and stored when she reaches Charleston.
