## DR. WILEY HITS ROOSEVELT ON PURE FOOD

WASHINGTON, D. C.—Dr. Harvey W. Wiley who will enter the Presidential campaign as a spellbinder for the Wilson and Marshall ticket, will make his chief object of attack the third term candidate's alleged effort to arrogate to himself the credit for a pure food legislation, and particularly the pure food and drugs law approved July 30, 1906.

In a statement given publicly by the pure food expert today, the shorter and uglier word is not used, but by indirection Dr. Wiley places before the third term a series of chronological facts calculated to stir the ready wrath of the first citizen of Oyster Bay. Dr. Wiley said:—

"Mr. Roosevelt has repeatedly claimed credit for the enactment and enforcement of the food and drugs act of June 30, 1906—the pure food law, so called. I have in my possession a printed letter of his, under date of August 3, 1912, in which he makes the claim that it was due to his activity that the bill became a law. In the letter Mr. Roosevelt says that Dr. Wiley and a few other impractical visionaries had been trying for years to secure the passage of a pure food law, but had simply played into the hands of the foes of such a measure. He says that, with the assistance of Mr. Garfield, then Secretary of the Interior, and others, the law was forced through Congress. Mr. Roosevelt says further, 'I forced the law through Congress; I enforced it well.'

"Now, the fact is nobody ever heard of Mr. Garfield's connection with the passage of the food and drugs act. Further, that act became a law June 30, 1906. Mr. Garfield became Secretary of the Interior March 4, 1907, according to the records and to his autobiography as published in 'Who's Who in America.'

"Still further, Mr. Roosevelt did not support the bill until he became aware that a tremendous public sentiment existed in its favor. Then he took it up as a popular move, and as soon as it became operative and it was seen to hamper operations of food adulterators he proceeded to cut the strength out of the law by appointing the Remsen Board.

"The Remsen Board, as every one knows who is acquainted with the facts, completely emasculated the pure food and drugs law, just as it was intended it should. The Remsen Board is wholly unauthorized by the law and with no legal standing whatever, as is shown by the report of the Moss Investigating Committee, and by a decision of the United States Supreme Court. It was appointed by Mr. Roosevelt for the sole purpose of rendering ineffective the pure food and drug law, and it did its work nobly."

Dr. Wiley will be the principal speaker at the National Conservation Congress, to be held in Indianapolis the week of October 1. His other engagements in Indiana are at Terre Haute, Lafayette and Madison. He will speak during the campaign in Boston, New York, Philadelphia and Baltimore.

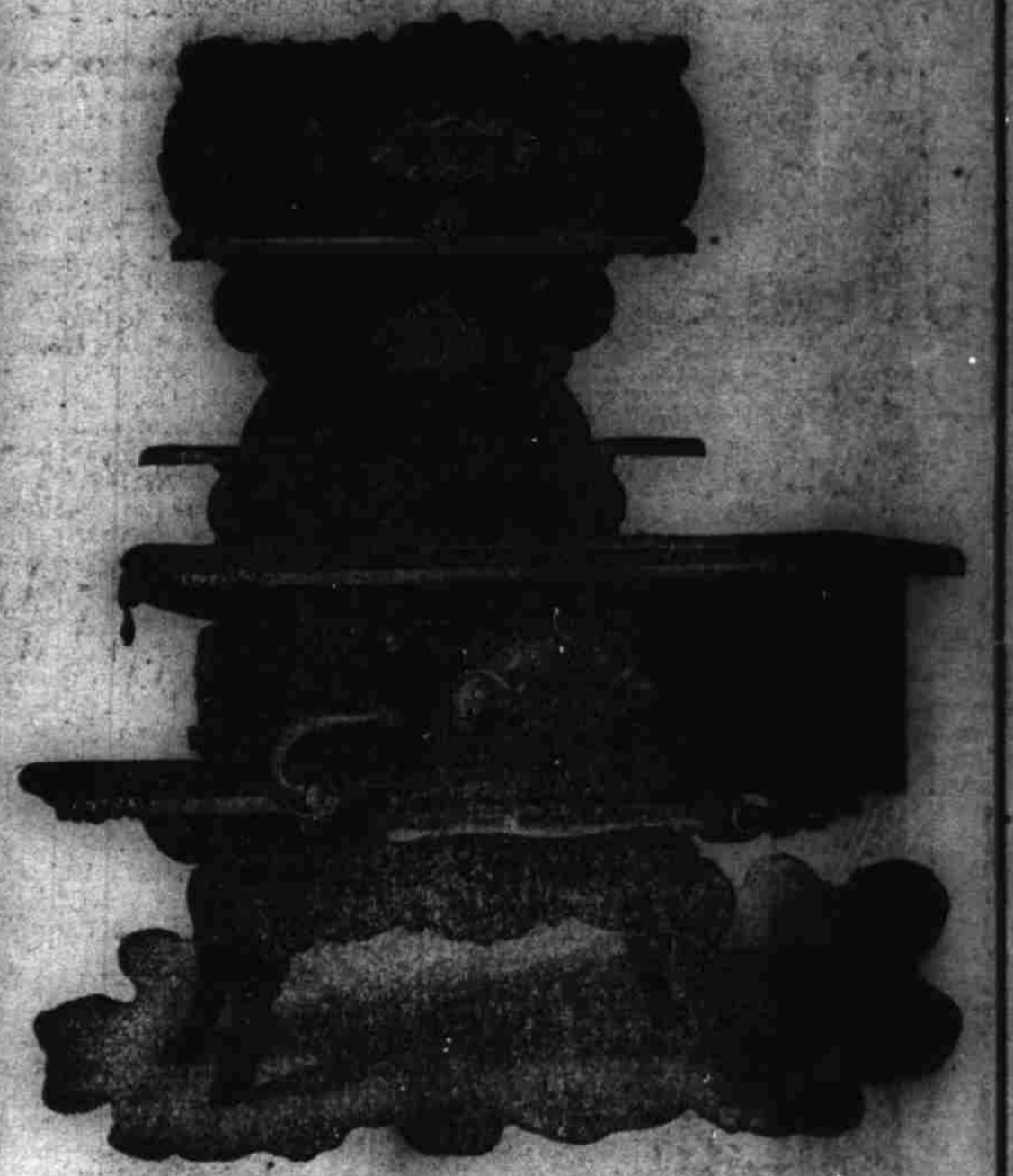
