Herrick, ex-Governor of Ohio, as ambassador to France. The fight against Taft's choice for the place is interesting in view of the presidential campaign in which Cummins is an avowed candidate.

New Party Gets Cruel, Cruel Blow

Hush! Tread soft and low. The Citizens' Party died aborning. John McCandless, Lorrin Andrews, C. G. Beckus, John Fleming, Albert Waterhouse, Walter Dillingham, Attorney Murphy, Andrews' partner; R. O. Matheson and W. R. Castle are among those whose names are given out as having heeded the confidential call of the confidential letters to the confidential meeting.

Others were called, but they did not choose to go. The press was not invited. In fact it was informed that it was not expected to be present.

Consequently the full details of the meeting cannot be given in exact sequence, but there is no secret about what happened.

First on the program was an address by Hon. Lorrin Andrews, the general effect of which was to impress upon his hearers that the Republican party was going from bad to worse, and a Moses was needed to lead it out of the wilderness. If the other Moseses were not available, why they could of course call on Lorrin, who was ready to sacrifice himself for the benefit of the cause.

It is stated that Lorrin waxed quite eloquent. He is reported to have made the opening remarks and the closing address. Some say he hypnotized the whole outfit and when he shouted "right" after the manner of Norwood he caught John McCandless in the act.

4 Trials May Do

On Monday morning at 10 o'clock Judge Dole will announce in the Federal Court as to whether or not separate trials are to be granted in the Mahuka cases, for the condemnation of the Federal building site. An informal discussion was held this morning, when attorneys for the various claimants argued the matter. The time for filing the answers has been extended until February 15.

United States District Attorney R. W. Brockens, in outlining the stand of the government in the matter, stated that he was of the opinion that all ends could be served by having four trials. There are four tracts of land to be considered, and although these have not been proved in the regular course of events, he is willing to admit them. The idea as he sees it is to have one trial for each tract and merge in it all the claims that are to be presented for that particular piece of land. This he thinks is the best way out of the tangle that is presented at the present time.

Attorney Frank Thompson, representing E. O. Hall & Son, stated that he thought his client was in a rather peculiar position and should be allowed a separate trial. In this case there is the special matter of trade damage to be considered, and also the damage that will be incurred in the removal of a quarter of a million dollars' worth of material.

CRUISER READY TO SPEED OUT; MISSION SECRET

If the West Virginia is being held in readiness to put to sea on some secret mission, only the "very high-ups" of the fleet are in possession of the information. However, there are plenty of rumors going the rounds, and, sorted and sifted to eliminate the improbable, the guess of several high-ranking officers who are in a position to at least make a keen forecast of the situation, is as follows:

The Navy Department, on orders of the State Department, has ordered the commander-in-chief to have one cruiser in readiness for instant departure on a certain mission. The West Virginia has been picked, and by coaling and provisioning last night is able to go to sea on a few hours' notice. The cruiser is "standing by" and will remain in a state of constant readiness until her orders arrive. If they do not come by Monday, when the other three cruisers of the fleet go out for their ten-day cruise, the West Virginia will remain here to act on called instructions. The mission will not take her on an extended cruise, and she will rejoin the fleet here when it is accomplished. Palmyra Island, over which there has been a vague report of possibility of com-

MIEHLSTEIN STOPS WORK ON CLUB STABLES NEW BUILDING

Construction work on the upper floor of the building being remodeled at the corner of Fort and Pauahi streets, by the Club Stables, has been stopped at the instance of Building and Plumbing Inspector Miehlestein, who has brought to the attention of Charles Bellina and his associates the clause in a city and county ordinance which prevents a structure intended for lodging or tenement-house purposes being erected within five hundred feet of a school.

The new structure now under way by the Club Stables is situated almost across the street from the Catholic convent.

KENTUCKY SHERIFF KILLS TWO FEUDISTS

RELIEF FOR CHINA ASKED

(Special Bulletin Cable.) SACRAMENTO, Cal., Feb. 10.—Lieutenant Governor Wallace has issued a proclamation asking for the relief of the Chinese famine sufferers.

Building Inspector Miehlestein cites provision incorporated in city and county building ordinance No. 29, which among other things stipulates a prohibition of construction of any building intended for lodging or tenement purposes in the vicinity of a school, public, private or sectarian, an orphanage or a similar institution, industrial or reformatory in its character.

Such a building as is said to be proposed by the Club Stables must be removed at least five hundred feet from a school building, unless the structure planned is intended to have less than five or more than twenty living rooms.

DESHA MAKES A LETTER PUBLIC ON FREAR FIGHT

In a letter that the Rev. Stephen Desha, the noted Hawaiian divine and those in Hawaii who are opposed to orator of Hilo, says he has received, and the poor ones who are being squeezed in our land. Delegate Kuhio, more right in siding on the fight the Delegate is waging against the reappointment of Governor Frear. The letter declares that Kuhio will carry the fight to Congress, if necessary. He stands for an uninstructed convention delegation and makes an appeal to the Hawaiians to stand together.

DECISION AFFECTS ALL HAWAII HOMESTEADING

The decision handed down by Judge Parsons of Hilo this week in connection with the Kaiwika homestead cases and with special reference to the case of the Territory vs. Henderson reached the Attorney General this morning.

Judge Parsons held briefly as follows: Henderson, although he had leased the land to the plantation, was fulfilling the necessary requirements of cultivation. Further, that although he never had a meal at his home he slept there at night and that no other place could be found which could be called his home. Lastly, that there was no need for him to plant trees, owing to the fact that there were a number of wild ones growing in the gulches on his land.
