White, an auditor of the New York Life Insurance company, had left it after making a correction in his testimony relative to the \$75,000 payments to Andrew Hamilton in 1904.

Mr. McCurdy said that the proportion of his commission on the former business paid to C. H. Raymond, after he left the firm of C. H. Raymond & Co., would be presented in a statement now being typewritten.

North Side Oil Company Closes Its Affairs.

The Northern Shawnee Development company disbanded today after spending \$2,000 in making two unsuccessful attempts to find oil or gas in Sheboy, north of North Topeka.

One well was sunk on the farm of T. D. Joseph, 1,628 feet in depth. The drillers stated that this is the deepest hole in Kansas made by oil or gas prospectors.

The hole on the Joseph farm has made considerable trouble during the past two months. Salt water in such large quantity was struck that it gushed out of the opening and threatened to damage considerable of the surrounding land.
