THE LOUISIANA FREE BANK SECURITIES
SENT TO WASHINGTON IN MILITARY
CUSTODY.—It will be remembered,
says the New Orleans Bee, of the
17th, that upon the surrender of the
Trans-Mississippi Department to
General Canby, the State and city
bonds belonging to the free banks,
and deposited with the State Auditor,
as securities for their circula-
tion, were delivered into military
custody along with the archives of
the State which had been removed
to Shreveport. It was supposed
that these bonds would be restored
to the keeping of the State Auditor
who would occupy as custodian
thereof the relation to the free
banks, contemplated by the act un-
der which they were created. This
expectation, however, was not soon
to be realized, and from the follow-
ing notice from Major Gen. Sheri-
dan, to Mr. Julian Neville, State
Auditor, which has been kindly
communicated to us by the latter
as information of interest to the pub-
lic, such a disposition of the securi-
ties in question would seem indefi-
nitely postponed:

Headquarters Military Division
of the South West,
New Orleans, July 15th, 1865.

To Julian Neville, Auditor of the
State of Louisiana, New Orleans.

Sir—I have respectfully to notify
you that in a telegraphic com-
munication received from the Lieu-
tenant General, I am directed to
place the Louisiana State, and City
Bonds now in my hands, with the
Adjutant General of the Army at
Washington, until further notice.

THE HERBERT COURT-MARTIAL.—
