We see by our exchanges that other cities the size of Butler are agitating the question of a local Building and Loan association to establish manufacturing. This, it seems to us, would be an excellent method for the people of Butler to pursue.

Secretary J. K. Gwynn, of the southwest Missouri immigration society, is in high spirits over the good results thus far of the society. He has distributed throughout eastern states 75,000 pamphlets and descriptive circulars and the inquiries received at his office are numerous.

Hon. E. E. Kimball, republican nominee for governor at the last election, is an applicant for the office of United States Attorney for the Western District of Missouri, and judging from the many endorsements he is receiving from the republican leaders and organizations in the state, with a good show of success.

THE NEW STATE MINE INSPECTOR.

Jefferson City, Mo., Jan. 4.—A committee appointed by Labor Commissioner Koehntzky met here to-day to pass upon the qualification of applicants for the office of State mine inspector. The committee was composed of V. C. Yantis, Gov. Morehouse's private secretary; James H. McCord, of Ray, John Perry, of Kansas City, J. L. McGrady, of Washington county, and Hon. C. H. Morgan. There were six applicants. The board organized by electing Mr. Morgan president and V. C. Yantis secretary.

The Removal of Shelly.

Kansas City, Mo., Jan. 3.—This morning at 7:30 o'clock there arrived on the Missouri Pacific train from St. Louis, Post Office Inspector B. F. Gullie, accompanied by a stenographer and Special Post Office Inspector Joseph P. Johnston. At 9 o'clock these gentlemen went to the custom house, called on Postmaster Shelly and presented him with the following document:

Executive Mansion, Washington, D. C.; Dec. 31, 1888.—You are hereby removed from the office of postmaster at Kansas City, in the county of Jackson and state of Missouri.

GROVER CLEVELAND, DON. M. DICKINSON, Postmaster General.

To Geo. M. Shelly, Kansas City. This was Mr. Shelly's first intimation that Tarsney had at last succeeded in his project to remove the Kansas City Postmaster.

VEST LEADS THE FIGHT.

Spool Cotton The Text For Tariff Debates in the Senate.

Republicans Turn Tail and Run from the Chamber—all Amendments Proposed Voted Down.

Washington, Jan. 3.—In the senate the tariff bill occupied the greater portion of the day. Vest has taken the leadership of the democrats and is opposing the monopolists' tariff bill with splendid effect. The greater part of to-day's session was devoted to tariff on thread. Vest evidently had studied the question and mastered it to perfection. It was a continuance of yesterday's debate largely, though, of course, the Senators did not confine themselves in their discussion to the matters immediately in question.

Howard, from all accounts, is an intelligent man. He is a native of England and worked 18 years as a mule spinner in that country, and five years subsequently as a mule-spinner in this country. At the time his testimony was taken he was the secretary of a labor organization in Massachusetts. His description of the condition of the New England protected laborer and the Old England free trade laborer made a striking contrast.

to enable the American manufacturers to hold the market at whatever price they saw fit to impose. He moved, however, to amend paragraph 314, relating to spool thread of cotton, by striking out "7 cents per dozen spools" and inserting 40 per cent ad valorem. He quoted from statements made by spool cotton manufacturers, J. P. Coates Clark and others, before the tariff commission in 1882, and before the ways and means committee in 1884, to show that they asked a less rate of protection in 1884 than in 1885.

Mr. Hawley said he did not understand why the senator from Missouri was criticizing spool thread manufacturers for their willingness to accept a lower rate. He did not understand that they were asking any change in the existing law.

Mr. Vest suggested that there was a good deal of money for them in the existing law. He proceeded to criticize the statement of a cotton manufacturer (Mr. Ferguson) before the ways and means committee of the House to the effect that the poor sewing women of the United States were benefited by the superior quality of the American thread, and he contrasted his statement with extracts from Helen Campbell's book describing the condition of the sewing women of the city of New York.

MARTIAL LAW IN OKLAHOMA.

The Settlers in Springer City Ordered to Depart.

Purcell, I. T., Jan. 4.—The Oklahoma invasion is coming to a climax and excitement is intense. Springer City, Oklahoma, a town of 3,000 inhabitants, is under martial law. The mayor and city treasurer have gone, and the United States troops are ordering all citizens out. This city is overrun with fugitives from the "promised land."

Late last night the troops stationed in the territory received orders to remove all settlers who are now locating claims in the vicinity of Oklahoma City, Purcell and Springer. Reinforcements from Fort Reno are expected to join troop B, United States cavalry, near Oklahoma City, and move on the settlers in the morning.

As might be supposed, those who have gone into the territory to take unlawful possession of claims are of the reckless kind and, therefore, trouble of a serious nature is apprehended at any moment. A collision between the soldiers and invaders is hourly expected to night and there may be bloodshed before to-morrow's sun sets.

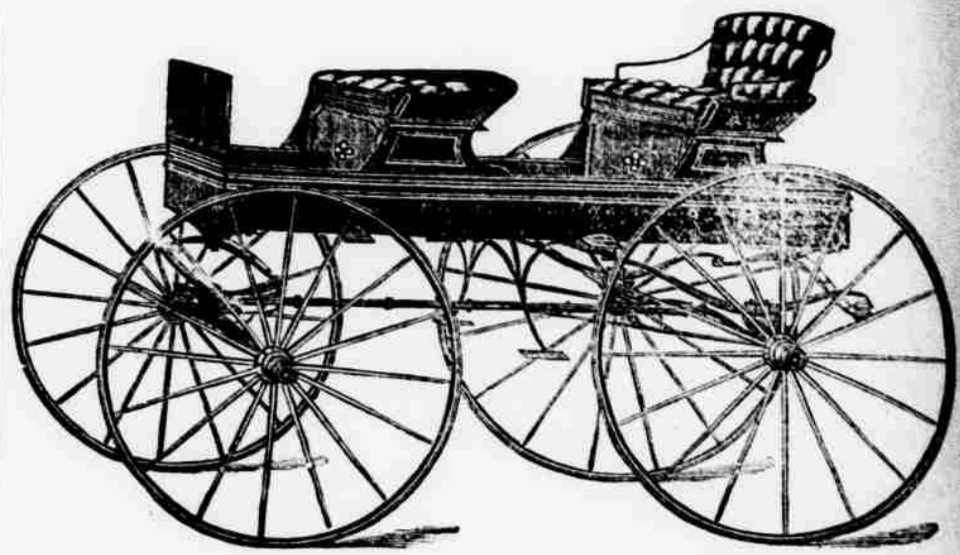
