Our Love System... The Mississippi River...

Greenville, Miss., Sep. 9, 1874. Editor Vicksburg Herald...

I take the liberty of communicating the following observations, prompted as they have been from professional experience of many years along this river.

So many have written on the subject of the Mississippi floods, and so many reports have been made on the river, by order of Congress...

Sufficient width, depth and proper direction must be given the space designed to carry off the food waters of the river...

Among the other evils attending the hitherto unskilled operations, was one originating from the Board of Levee Commissioners.

At times a planter on the front (some retired member of the Board and disaffected from lack of re-appointment) or a disappointed politician was always ready to en-join, or to declare the acts of the incoming Board "unconstitutional."

This being multiplied by the number of such points, will give some idea of the retardation of the food-water in the entire river, and its incapacity for discharge.

and may be partially cultivated after flood time. This giving up the points to the river in high water will obviate the necessity of cut-offs...

After awhile the levees will become lower instead of higher as at present, and as the system is developed they, in time, will not be required.

While operations are going on, there must be entire harmony and concert of action on both sides of the river...
