As the string of wagons turned into Third avenue a dense throng of howling men and women surged upon them from all sides, while bricks and stones rained down from roofs and windows.

The mob was still chasing and clubbing the strike breakers when two patrol wagons filled with police arrived from the Fifth street station in charge of Capt. O'Connor.

Major Gaynor made a vigorous statement this afternoon in which he re-iterated the present White Wings strike as "the meanest and most arrogant piece of business ever known."

"I can best answer your questions by saying that the city officials are not trying to 'break' any strike. The drivers of the ash and garbage wagons have quit their jobs and their places are being filled by others.

"When men in city departments quit they are struck from the payroll and their employment by the city is at an end. Their places then have to be filled from the Civil Service list.

"The labor leaders who came to see me demanded that the city of New York cause to remove ashes and garbage at night. I told them the day removal caused general complaint throughout the city of the ashes lying in the faces and eyes and clothes of people and of the smell of the garbage that we were forced to clean up in many of our streets.

DEMANDED TWO MEN TO A CART AND MORE PAY.

"They said that the city should have two men to a cart instead of one. They said the job was too lonely for one man in the dark winter nights. They also said the job was too cold at night, although the work ought to keep any man warm. I told them that the night service would not be discontinued. I also reminded them that the city was not the employer but the employer was the individual that the Commission could only employ the number of men provided for in the budget; that he could not spend money which had not been appropriated for him; that the men were in public employment.

"The men are made of a size for one man to handle, no way. I also pointed out to them that the men worked only eight hours a day and were paid much the highest wages paid anywhere for such services. It was all useless. These men were bent on making the officials and people of this city knuckle down to them. The householder of this city will bear any inconvenience before they will allow that piece of business ever again to be carried on in their city. They will turn around and do this meaning this. This city will knuckle down to nobody, but will treat everybody justly."

EDWARDS SAYS SWEEPERS ARE BEGINNING TO QUIT.

Commissioner Edwards said this afternoon that a strenuous effort was being made by the strikers to induce the sweepers to walk out. In the morning, he said, 128 sweepers had quit. That the entire body of sweepers would quit before the close of the afternoon was the prediction of the International Brotherhood of Teamsters.

The first move on the part of Commissioner Edwards was made under his personal direction at Stable C, One Hundred and Thirty-third street and Broadway, when thirty wagons were sent out with a guard of thirty patrolmen and two mounted men.

Up to 10 o'clock no cart had left any of the big stables below Houston street. The stables had a guard of from 20 to 30 patrolmen in addition to flying squadrons of mounted men.

ALL NIGHT SPENT IN MUSTERING STRIKEBREAKERS.

The mustering of strikebreakers in the various barracks established by the Street Cleaning Department continued throughout the night. Private detectives were engaged to escort the men in little bunches, so that they could trickles into the stables without attracting attention.

Mayor Gaynor manifested his deep concern in the situation to-day by sending to the secretary, Robert Adamson, to make the rounds of all the stables in Manhattan and report on the situation. Secretary Adamson accompanied Commissioner Edwards on his rounds. He was accompanied by a team of five horses and a driver to send wagons out of the Harlem stables. While he did not witness any actual violence he was impressed by the size of the mob that followed and feared the strikebreakers.

LCSS OF TIPS THE REAL KICK OF THE STRIKERS.

While the strike leaders originally asserted that the object of the strike was to compel the city to abolish the prevailing system of night collection of garbage because it worked such a physical hardship on the men, the strikers have now admitted that the real kick was not such a physical as a financial hardship.

MISSILE FROM ROOF KNOCKS DRIVER INSENSIBLE.

Thomas Arkell, twenty-two years old, of No. 125 Stuyvesant avenue, Brooklyn drove the first of the three wagons to leave Stable H, at Forty-eighth street this forenoon. Two patrolmen guarded each wagon, but as Arkell turned into First avenue a shower of bricks came down from a roof. One of the missiles hit the driver, hurling him out of the cart. He fell unconscious to the pavement and was carried to the East 47th street station after an ambulance surgeon had attended and bandaged his head he went home.
