WILSON OUT AS GOVERNOR, JUST A PRIVATE CITIZEN FOR NEXT THREE DAYS

Hands Seals to James Fielder, Now Executive, Whose Courage He Praises.
COP DIDN'T KNOW HIM. Held Him Up After He Left State Capitol Until President-Elect Was Identified.

TRENTON, March 1.—Woodrow Wilson became a private citizen at noon to-day and until noon of March 4 he will be a private citizen. He turned over the seal of New Jersey to James Fielder, President of the Senate, who automatically became Governor of the State.

The ceremony took place in the Assembly Chamber, which was jammed until the walls almost bulged. In the galleries were crowds of women who made as much noise as the men. The chamber was decorated with American flags and yellow and black bunting—the inauguration colors.

STRIKE NOT ENDED, IS CRY OF RIOTOUS GARMENT WORKERS

Police Reserves Scatter East Side Mob Repudiating Peace Terms Made.
I.W.W. MAKING TROUBLE. Concessions on Both Sides in Settlement Reached by the Leaders.

An insurrection in the ranks of the striking garment workers, festered by little leaders who have banded together for the purpose of prolonging the struggle, this afternoon threatened to upset the peace agreement by which the great strike had been apparently settled. It took visible form in a demonstration in front of the Jewish Daily Forward Building, No. 125 East Broadway, where a semi-organized mob of several hundred men and women gathered and loudly demanded a special edition asserting the strike had not been settled.

At one time the noisy throng stormed the front doors and several windows were broken. Capt. Ormsby of the Madison street police station turned in a call for the reserves. After fifteen minutes' work the mob was herded in Seward Park, opposite the Forward Building, without violence. For some time the crowd remained there and glowered at the newspaper office. There was practically no clubbing and no arrests were made.

SEVERAL THOUSAND WORKERS IN THE PROTEST. Apparently the demonstration represented several thousand workers affected by the agreement reached last night, but there is no means of estimating how many other workers can be induced to repudiate the peace terms agreed upon by President Rickert and Eugene S. Benjamin, representing the Allied Clothing Trades Association. Those already voicing dissatisfaction claim that they have been "sold out" and that they will not get the fifty-hour week they demand. They also think \$1 a week is not enough of an increase in wages.

In the crowd that besieged the Forward Building were many persons identified with the Industrial Workers of the World. Rickert and his associates have done their utmost to keep the activities of these agitators at a minimum, always aware that the I. W. W. leaders had an ambition to take the strike out of his hands. Evidently they had the sympathy of some smaller strike leaders of the United Garment Workers, for they worked to keep the strike alive as long as possible. It has now been in progress over two months and has dealt a blow from which the clothing industry of New York will not recover for years. It has involved the loss of millions of dollars and has spread starvation and misery all through the east side.

9,000 GARMENT MAKERS AFFECTED BY THE SETTLEMENT. The settlement announced last night by Marcus M. Marks, who acted as mediator, involves practically all of the 9,000 workers still idle if President Rickert succeeds in carrying out the union's end of the agreement to return to work.

SULZER BOARD TO CALL DR. AUSTIN FLINT IN THAW BRIBE INQUIRY.

Wants Facts on Alleged Conspiracy in Favor of White's Slayer at Matteawan.
ALBANY, March 1. Gov. Sulzer's committee of inquiry hopes to conduct its investigation of the Thaw bribery charges on Monday, when Alfred Henry Lewis, Dr. Austin K. Flint and Val O'Farrell, all of New York, are expected to testify. Dr. Flint had written a letter to Gov. Sulzer, when the Governor referred to the committee, in which he alleged a conspiracy existed to dismiss all the attacks of the Matteawan State Hospital who were unkindly to Harry K. Thaw. The committee will question Dr. Flint as to his knowledge of such charges.
