CITY MOVING DAY BRINGS TANGLE AMONG TENANTS

150,000 Van Loads of Furniture Ready to Be Moved To-morrow.

WOULD TAKE 24 DAYS Scores Likely to Be Homeless—New Legislation Complicates Situation.

ALLOWS LEASE CONTEST Agreements Among Homeholders Add to Congestion, Say Realty Men.

With October moving day only twenty-four hours away the prospects are it will be attended by more confusion than ever before in the history of the city. Hundreds of families have their belongings packed ready to move, which they must do to make way for other tenants, and are themselves confronted with the probability of not being able to enter their new apartments because the present occupant has not been able to find other quarters and may refuse to leave. Real estate renting agencies admitted yesterday the situation is chaotic and that they are powerless because of the measures passed by the extraordinary session of the Legislature.

What will be the outcome of the shuffle no official or real estate expert would dare say. Many were of the opinion that scores of families will find themselves homeless before sunset to-morrow night, with the prospect of having their furniture lie in the streets until it is removed by the Bureau of Incumbrances, as their chance of obtaining room for their belongings in a storage warehouse is exceedingly remote. Best estimates placed the number of van loads of furniture to be moved at 150,000, which, with every van in the city operating, would take 24 working days of eight hours each to transport. As all vans are not operating, it is estimated that 200,000 van loads will be needed to get the furniture off the streets by the 1st of October.

Not one officer of a score of realty agencies and of the several municipal bodies brought into being because of the housing shortage and rent profiteering looked optimistically toward to-morrow. Nearly all of them threw their hands in the air when asked for an opinion. All agreed the situation was without precedent in the city's history, and the realty men in particular held that the recent legislation, instead of remedying matters, made them worse.

Handreds of thousands of apartments now occupied were leased to other families as far back as last July and August. The present occupants assigned to the landlords their intention of vacating by October 1, and the landlords, without considerable debate within labor circles and represents a victory for the more conservative elements over the right to evict a tenant save for three reasons: either because he wishes to occupy the apartment himself, because the tenant is undesirable, or because the lease is to be renewed or for other reasons.

Arthur J. W. Hilly, chairman of the Mayor's Committee on Rent Profiteering, submitted a statement which opens up the possibility of a contest of all leases to become effective to-morrow which were signed in the last few months. Mr. Hilly said the emergency legislation which he proposed would allow the tenant to contest the lease and advanced rental which they signed under duress, fearing they would find themselves homeless on October 1.

White House Sheep Are Sent Back to the Farm

Some already had been disposed of, but the bulk of the flock, by President Wilson's orders, was returned to William Woodward, Bellair, Md., who sent the sheep to the White House during war days when the laundry needing trimming and wool was in demand.

A. F. OF L. OUT AGAINST 'REDS'

Repudiates Position of British Labor as Well as Soviet Rule. GOMPERS STATES POLICY American Labor Will Depend on Ballot to Effect Needed Reforms.

Special to THE SUN AND NEW YORK HERALD. WASHINGTON, Sept. 29.—The American Federation of Labor has declared its independence of the radical and revolutionary labor movements of Europe. In a statement published to-day in its organ, the American Federation, the American body repudiates the labor movement of Great Britain, declares utter lack of sympathy with the policies announced by the International Federation of Trades Unions, which met last month at Amsterdam, and declares against the Soviet movement of Russia. It is signed by Samuel Gompers, president, and Mathew Wohl, vice-president.

It is regarded as the most important pronouncement ever made by labor in America and is expected to have far-reaching international effect. Repudiation of British labor and of the international organization is based on the refusal of American labor to join in a socialistic movement which aims to support the Soviet system of Russia and is urging support of world revolutionary activities. Socialism and all that the Russian movement means is utterly condemned.

Depends on the Ballot. Recognition is made of the fact that the ballot in America offers the opportunity for the peaceful operation of universal suffrage. The position taken by the American Federation of Labor is regarded as the most important development in opposition to the effort of the Russian radicals to foment world disorders. It is in line with the nationalistic tendency of the American public in its repudiation of the adventurism in the realm of international politics contained in the League of Nations.

Supports Millard's Position. BUDGET SLASH TO \$340,000,000 MAKES DISCORD

Board of Estimate Unable to Agree on Salary Increases. MAY HALT BUILDING Question of Deferring Erection of New Court House Comes Up Again. DEEP CUTTING NECESSARY Figures by Experts Indicate Heavy Advances Over Last Year's Expenses.

Before they begin to prune departmental estimates which form the basis for the new city budget officials suggested at their first meeting on the subject yesterday that they try to agree on a general policy regarding all salary raises and new construction work. Faced with figures which are staggering, some of the officials proposed marking a start by eliminating all building not absolutely necessary and holding down salary raises to the lowest possible point. On both propositions there was wide difference of opinion. The Board of Estimate, sitting as the budget committee, will try to arrive at an agreement to-day and then will tackle the estimates.

Court House Up Again. Henry H. Curran, Borough President of Manhattan, yesterday announced that he would not build any new buildings in Manhattan, but that he would build a new court house. He said that the present court house is too small and that a new one is needed. He also said that he would build a new police station and a new fire station.
