House Joint Resolution No. 67. JOINT RESOLUTION. Preparing Amendments to Articles Two, Three, and Ten of the Constitution of Ohio.

ARTICLE II. Section 2. Senators and representatives shall be elected biennially by the electors of the respective counties or districts.

ARTICLE III. Section 1. The executive department shall consist of a governor, lieutenant-governor, secretary of state, auditor of state, treasurer, and an attorney-general.
