"Prior to 1890 the expenditures of the federal government, per capita, ranged from \$2.35 to \$2.00. They now range from \$5 to \$6. In addition to this the State expenditures average \$9.10 per capita, making a total of between \$14 and \$15 per capita.

Admiral Sampson sends word to the Navy Department that three of the Spanish cruisers in Cervera's squadron may be saved. The Cristobal Colon, he says, is not badly damaged, while the Infanta Maria Teresa and the Vizcaya, he thinks, may be saved without much difficulty.
The first news of the battle to reach Santiago was conveyed by seven sailors from one of the torpedo boat destroyers, who escaped to the shore and walked into the fortress Scaopa. It is also said that a number of sailors from the cruisers were reported, later, as having reached Santiago overland.

Section 2. No person shall sell milk within the city of Canton until he has exhibited to the inspector of meat shops and dairies his cows and stables and milk houses and milk vessels, and the food and water supplies for animals of all persons from whom he obtains milk, and received from said Board a certificate showing that the cows are healthy, and the stables, food and water supplies are in good sanitary condition, which certificate shall be posted up conspicuously in his stand, wagon or other place, and no person shall sell milk, otherwise to be exhibited on demand. Any addition of non-inspected cows to the herd of any dealer shall be reported to said inspector, and no person shall sell, or receive, sell, or offer for sale, the milk of any cow condemned at any inspection until such condemnation is removed on subsequent inspection, and no person shall sell, or receive, sell, or offer for sale, any milk, cream, or butter, made and signed by the inspector and deposited with the Board of Health.

Section 3. No person violating any of the provisions of the foregoing rules and regulations, or failing to comply with any of the duties herein imposed, shall be liable to a fine of not less than \$2.00 nor more than Ten (\$10.00) dollars for each offense. These rules and regulations shall take effect and be in force from and after their passage and legal publication.
