ONE IS DEAD AS RESULT OF FIGHT

Jesse Keys Shot in Heart by E. F. Fenmore in Row After Crap Game

KEYS MATCHED SCRAP Prisoner Says He Acted as Peacemaker and Later Is Attacked by Pair

WENT HOME TO MISS FRAY Claims Shot Fired When Two Men Cornered Him Beside Home on North Quincy

As the culmination of a running fight in which Jesse Keys, E. F. Fenmore and an unidentified man participated Sunday afternoon in the northeast part of the city, Keys is dead, Fenmore, an automobile mechanic, living at 710 North Quincy avenue, is in the city jail awaiting the filing of a state murder charge and the unidentified man is sought by the police. Keys, who lived at 1442 Admiral, was shot to death in front of Fenmore's home after Mrs. Fenmore, who saw the fight between her husband and the two men, stepped on the front porch and fired a shot from a revolver into the ground in an effort to stop hostilities. Falling in this she handed the weapon to her husband, who fired one shot over his shoulder as he ran from his two assailants.

According to Fenmore's story, he saw Keys, whom he knew at a crap game in progress northeast of the city limits Sunday morning. Keys, the unidentified man and a third man, known to Fenmore as White, left the game before Fenmore. As Fenmore was coming into town, he passed the three and saw Keys strike White in the face with a fist to the ground. He talked to the men, he said, and succeeded in stopping the fight. Then he went to his home.

Claims Attack Unprovoked. About 1 o'clock he again left home and was walking north on Quincy avenue and saw Keys and the other man coming toward him. The man with Keys cursed Fenmore, and drawing a knife, accused the latter of causing the fight of a few hours before. Fenmore ran toward his home, and was followed by the pair who threatened his life, he claims.

Fenmore entered his house and locked the door. The pair demanded entrance and when Fenmore refused to open the door, Keys kicked it in. Fenmore went out the door and seized a short piece of iron bar which he threw at Keys, but the missile missed its mark and the two men continued to advance on Fenmore.

First Shot Did Not Stop Pair. At this point Mrs. Fenmore came out of the house and fired a revolver into the ground, but the attack continued. Fenmore took the weapon from his wife and started toward the house. The pair followed and were about to strike him when he fired one shot from the revolver over his shoulder. The bullet took effect in Keys's heart and the latter dropped to the ground dead.

Keys' companion, an older man, immediately left the scene of the shooting. Fenmore tossed the revolver on a bed in the house and took a street car for town. On Third street, Cincinnati avenue he saw Captain W. R. Wilkerson of the police department, with whom he was acquainted, left the car and save himself up to the officer. Wilkerson took him to the police station, where he and his wife were questioned for half an hour by James Patton, chief of police. And other officers. After the investigation Fenmore was committed to jail and the wife released. The officers say the prisoner and his wife told similar stories of the fatal shooting and they are now searching for the man who assisted Keys in the alleged attack on Fenmore.

Two Automobile Men Shot. GRAHAM, Texas, April 17.—Abe Killo, 37, was shot and instantly killed, and his father, about 55 years of age, was seriously wounded by Fred Hughes, former deputy sheriff. In a dance hall at South Bend, near here today. Both men are said to reside at Ardmore, Okla. Hughes came here immediately following the shooting and gave himself up to the sheriff, although none of the details of his statement could be obtained.

Wilhelm Drowns As Mate's Body Is Taken Away

DUBOIS, April 17.—Never was contrast between former glory and present state of humiliation more accentuated than while Wilhelm, the former German emperor, followed the body of his wife, Augusta Victoria, to the station at Maarn, where he entrusted the faithful companion of his grandeur and his sorrows to his sons and friends to take back to the fatherland.

The emperor that was and the ex-crown prince and other sons present were all attired in full uniform of the Prussian guard, their helmets crepe covered.

The funeral procession arrived at the little station at Maarn in darkness only broken by the light from a few lamps on the railway embankment. When all had collected around the coffin, the court chaplain, Doctor Binsder, delivered a brief oration. The coffin was then placed in the railway carriage, which Wilhelm, Frederick William and Princess Louise entered and remained for a few minutes.

For a brief period Wilhelm became dimly visible to those who had gathered to watch the ceremony, his figure that of a man broken by sorrow. Princess Louise entered the automobile with her father, the door closed and the car slid on, carrying the ex-liege back to confinement at Dornum, to face his fate without the devoted wife who shared his downfall.

FACILITATE PRICE PROBING IS PLAN

Legislation to Help U. S. in Inquiries Favored by Trade Board

COSTS ARE TOO HIGH Prices Generally Not Reduced in Proportion With Drop for Raw Materials

WASHINGTON, April 17.—Legislation to eliminate unnecessary brokerage transactions, to facilitate a wide distribution of information regarding market conditions and to strengthen the powers of the federal trade commission in a report on the general industrial situation, drawn up at the request of President Harding and made public tonight at the white house.

"Open price associations" which operate within the law to keep the respective members advised confidentially of another's price schedules are accused by the commission of contributing to the maintenance of unduly high retail prices. It is suggested that means must be found to reduce costs of necessities, such as fuel and housing, before other commodities can come back to normal.

Shrinkage Was Certain. "It should be said," the report concluded, "that following the disordered condition of the world's affairs, a shrinkage in value is inevitable in the retailing stage, and that the more quickly restored to the producer, the laborer, the manufacturer, the jobber, and the retailer, will each share at once in the unavoidable loss and further that any effort by any element to place its share of the common loss on the shoulders of others, and particularly of the consumer, can but result in a continuation of the conditions under which the country is now suffering."

SEND RELIEF TO TORNADO VICTIMS

TENNESSEE, Texas, April 17.—Reports from Queen City, Okla. county, Texas, today declare that several persons were killed in the cyclone which visited this section Friday. The death list in Miller county, Arkansas, is officially placed at 18. Relief workers at Queen City report that the exact number of deaths is not known and that search for bodies was being continued. These workers appealed for outside aid in their work.

STORM TOLL 100, REPORTS INDICATE

Property Loss in 6 Southern States Will Run Into Millions

CHECK NOT COMPLETE Wires Still Down and Many of Isolated Sections Are Not Yet Heard From

RELIEF IS SENT SUFFERERS Food and Clothing Carried Into Area; List of Injured Also Is Mounting Higher

MEMPHIS, April 17.—Reports coming from isolated sections tonight indicated the death toll from tornadoes and rain storms which swept six southern states Friday and Saturday will reach 100. While the loss to property and crops is estimated will run into millions of dollars. The known dead are 94.

Many sections are still shut off from the outside and reports of additional casualties are slowly coming in from relief districts.

NO CHANCE SEEN FOR SOVIET PACT

Secretary Hughes So Informs Gompers in Note on the Situation

RED SYSTEM FLYED 'Soviet Russia Giant Vacuum' He Declares in Answer to So-Called Propaganda

WASHINGTON, April 17.—Secretary Hughes, writing to Samuel Gompers, president of the American Federation of Labor, who asked for a statement of "the facts" regarding Russia, indicates definitely that there is no prospect of a resumption of relations with the United States while the soviet political and economic system remains.

The letter of the secretary of state makes direct reply to various statements, characterized as propaganda, contended that resumption of relations, trade or political, with the soviet, would open a great current of trade advantage to the United States and that large shipments of Russian gold have already been made to other countries in payment for goods.

Soviet Russia, Secretary Hughes declares, "is a gigantic economic vacuum," and he adds that "no evidence exists that the unfortunate situation is likely to be relieved so long as the present political and economic systems continue."

COLD WAVE IN NORTH

Party of Travelers Marooned for 50 Hours in Unheated Train Reaches Chicago. CHICAGO, April 17.—A cold wave followed the blizzard which swept an area from the Rocky Mountains to the Atlantic States Friday and Saturday leaving a trail of death and desolation in its wake. In the central west conditions were slowly returning to normal. The snow which fell in Wisconsin, Nebraska, Michigan and Illinois had almost vanished tonight. Railroad schedules were being returned to normal and wire communications had been restored except to a few points.

1,000 In Irish Party Sailing For U. S. Port

DUBLIN, April 17.—Nearly 1,000 Irish emigrants embarked on Queenstown yesterday and today bound for the United States. Several attacks on the consular party were reported today. Two consular party were dangerously wounded. The Irish emigrants, which formed a force went through the streets firing bombs and shooting indiscriminately.

A bomb attack was made on a consular party at Queenstown Saturday night on North Quay, Dublin. The auxiliaries returned the fire and three members of the attacking party were seen to fall.

The consular party, which included a priest, a soldier and a constable and two women were wounded.
