WHEREAS, The new law passed at the last session of the legislature requires that all taxes be paid at the county seat, and, inasmuch as it has been customary for the Sheriff to visit each precinct, and, taking into consideration the fact that many persons will not be aware of the requirements of the new law, therefore, I have decided to follow the old custom in collecting the taxes for the year 1892; and

Inasmuch as Alsea, Tum Tum and Summit precincts have been divided by the division of the county and the usual voting places are not in Lincoln County, persons residing in those precincts can pay at the places mentioned which shall be most convenient to them.
All not paid at the time above-mentioned must be paid at the county seat.
Taxes remaining unpaid after June 1, 1893, will become delinquent.

From Pioneer.

Perhaps you have never heard of this place. It is not very large, like many other places along the line of the O. P. died in growth when the R. R. arrived.

We are on tide-water, and a natural place for a townsite on the O. P. and the county roads over which all the travel with teams pass from Corvallis to Newport.

Uncle Barney Morrison and wife are the only old settlers remaining. They own a nice farm and are in comfortable circumstances. Barney spends his leisure hours in trapping beaver and other furs, at which he is an expert.

Mr. Olson owns a fine farm that is under the management of Messrs Blalock and Frer. The boys are great workers and will soon have it in a paying condition.

While we are not the largest town in Lincoln county we do not expect to be the smallest. Nature has placed a mountain of what is now called by experts to be the finest and best rock in Oregon, at our place, and within three or four hundred yards of the railroad.

Mr. John Howell, of Salem, bought forty acres of school land a few years ago supposing it to be a good piece of land on the Yaquina Bay, but when he came to view it he was surprised to find a mountain of rock and worthless burnt woods. Now it has proven to be of great value to him. The contractors are now on the ground and propose to open it at once as they have contracts to fill within the next thirty days; taking over thirty car loads. Already we hear the sounds of the blasts echoing through the valley, telling us the men are at work.

Barney says this means a boom for Pioneer and we will soon hear the sound of the saw and hammer. Pioneer has been in a long sleep, but we are awake now. The new management of the O. P. seems to put new life in everything along the line.

E. W. Powers has come with his family from Oregon City and will take an active part in the new town. They will run a boarding house and hotel for the accommodation of the quarry men and traveling public. Mr. Powers needs no recommendation as landlord.

Current Comment.

E. E. Sharon, city assessor of Pendleton, wrote to George E. Chamberlain, attorney general, for his views concerning the Manley-law to see if Mr. Chamberlain supported the opinion entertained here that the assessment of the school district and city must now be made under that law.

The attorney general kindly replies at length to the letter, setting forth many facts of interest in explanation of the new assessment law. Mr. Chamberlain states that he is clearly of the opinion that the new law must now govern assessments. He quotes Section 9 of the act, which provides that "all laws providing for assessors in or assessments of property by any school district, incorporated town or city" and all laws in conflict herewith be and the same are hereby repealed. This repeals any other method of procedure in direct terms.

The Manley law, he says, was filed February 21st, 1893, in the office of the secretary of the state, and while it was not approved by the governor, on account of the emergency clause, it took effect, under the decision of the supreme court in the case of Brigs vs McBride, 17 Or., 460, from and after its passage.

Another paragraph in Mr. Chamberlain's letter says: "It is true that section 4 of the law requires that each school district and incorporate town and city shall notify the county clerk of the rate per cent of the levy made by it on or before the first day of February, and that it is impossible to comply with said section because the time had elapsed when the law took effect. The provisions of section 4 are, it seems to me, directory, and a failure to comply strictly therewith would not invalidate the assessment or the levy made thereon; and the notice required to be given under said section could be given at any time before the meeting of the county board of equalization."

So it appears that Pendleton's assessment, and that of the school district, must undoubtedly be made by the assessor, and that the taxes can not be collected until those by the county are gathered by the sheriff. Those do not become delinquent until April of 1894.—East Oregonian.
