KILLED IN ACTION

Lieutenant Seth C. Hetherington, son of former Civil Service Commissioner Albert G. Hetherington, 1529 Chestnut street, has been killed in action during the recent drive in the Argonne.

"I Want No Tears," He Wrote
He had been urged by his instructors at Port Niagara to go into the cavalry, but refused.

"No," he said, "the infantry boys will get the action in this war. He was a strict disciplinarian, but was a friendly and well-liked man by his men.

"It is necessary that I make the supreme sacrifice," he added, "I want no tears but only relief that I am able to give my life for my country."

Lieutenant Morris was attached to the Tenth Aero Squadron, First American Army Corps, when he disappeared. The last letter written by the officer was on September 27, and in it he said that he had been in action and had had some holes shot in the wings of his plane.

Lieutenant Wistar Morris is a graduate of the Westboro school and an undergraduate of Princeton University, class 1915. He enlisted soon after Congress declared war on Germany and was among the first high school boys to be picked for training in France. He went overseas September 25 last year and has been in several training camps in France, where he was finally assigned to the Tenth Aero Squadron.
