As reorganized, the enterprise will continue to do a general cotton oil business.

**NOTICE OF ELECTION.**

State of South Carolina,  
County of Laurens.

Whereas, petitions signed by more than one-third of the qualified electors and freeholders of Long Branch School, Scuffletown No. 1, Laurens County, South Carolina, asking for an election upon the question of voting a two (2) mill tax to be used for school purposes in said school district, has been filed with the County Board of Education, an election upon said question is hereby ordered, said election to be held on the 17th day of September, 1909, at Long Branch School House, under the management of the trustees of said school district.

Only such electors as return real or personal property for taxation and exhibit their tax receipts and registration certificates as required in the general election shall be allowed to vote.

Those who desire to vote for said tax shall cast a ballot containing the word "Yes" written or printed thereon; those who desire to vote against the tax shall vote a ballot containing the word "No" written or printed thereon.

Polls shall open at the hour of 7 o'clock in the forenoon and remain open until the hour of 4 o'clock in the afternoon, when they shall be closed and the ballots counted.

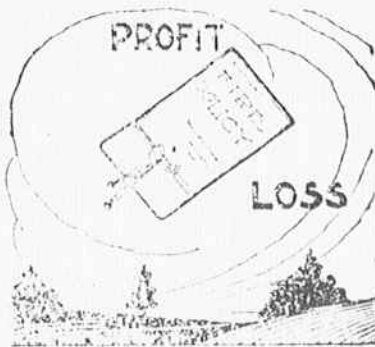
The trustees shall report the result of said election to the County Auditor within ten days thereafter.
