



SECRETARIES REEKS FIRST BIG PEACE PLANS

Secretary of Navy Asserts Nebraskan Laid Foundation for World League Through Arbitration Treaties.

WASHINGTON, Jan. 9.—William Jennings Bryan was given credit by Secretary of Navy Charles D. Eastman today for laying the foundations of the league of nations movement through arbitration treaties negotiated by the former secretary of state.

In view of published reports that the three-time nominee of the Democrats for the presidency again aspired to lead the party in campaign, Secretary Eastman's statement created one of the most interesting moments of the day.

Stands on Record.

Asserting that no man appreciative of the changing conditions believes the coming presidential election predicated for any party, Secretary Eastman today stood on his record.

"But the Democrats assembled here," he continued, "must bear in mind that the party is sometimes the only one with an own reward. A shell-shocked world, with unrest and the spirit of change, admonish us that more is to be done than a good record of performance.

Recalling the strenuous antagonism encountered by President Wilson and Jackson, the speaker continued:

"In this hour the same intolerance of those who think themselves superior and spurred to ride on the backs of others is aimed at the world leader in the White House.

ANTITYPHOID VACCINE MAKES MUCH PROGRESS

HANOVER SUES ISELE, SAYS OPTION BOOSTED

M. Hanover late Thursday filed a bill in chancery court against Joseph Isele in which the old Miller Brewing company property at Main street and Washington avenue is involved.

Hanover charges that Isele attempted to raise the price of an option on the property after he had paid him part of the sum on which they first had agreed.

According to the bill Isele sold Hanover an option on the property for \$41,000.

Hanover claims to have paid Isele \$5,000 of the sum, after which Isele is alleged to have gone to Milwaukee to get a deed to the property, but had the deed made out to himself instead of Hanover.

Hanover says he attempted to raise the price of the option from \$41,000 to \$42,000.

Hanover and S. E. Murray are attorneys for the complainant.

MEXICAN EARTHQUAKE BRINGS ERUPTION. MEXICO CITY, Jan. 9.—A violent volcanic eruption has been caused by the recent earthquake near Cordoba, where Cerro de San Miguel, a small and apparently extinct volcano, has been burst in twain. The new crater is throwing out smoke, ash and flame, while lava is flooding the nearby territory in a stream more than 200 yards wide, resulting in not less than 200 deaths.
