WAXAHACHE.

A True Bill for Murder-Work of Grand Jury and District Court. WAXAHACHE, Tex., March 22.—It will be remembered by the readers of THE GAZETTE that on Friday morning, October 30 last, Mr. John C. Spradlin of Avalon, this, Ellis county, was found dead in his wagon on the premises of Mr. W. A. McFarlane, one or two miles from Avalon.

The breach between Employer and Employee is apparently growing wider. Arbitration on difficult questions so far has only effected temporary settlements. New issues are constantly arising from unforeseen causes, and the results are strikes, boycotts and suffering for the wage-worker.

Our great troubles in this part of the country are the disagreements between railroad companies and their employees. The Knights of Labor feel their power and are disposed to exercise it.
