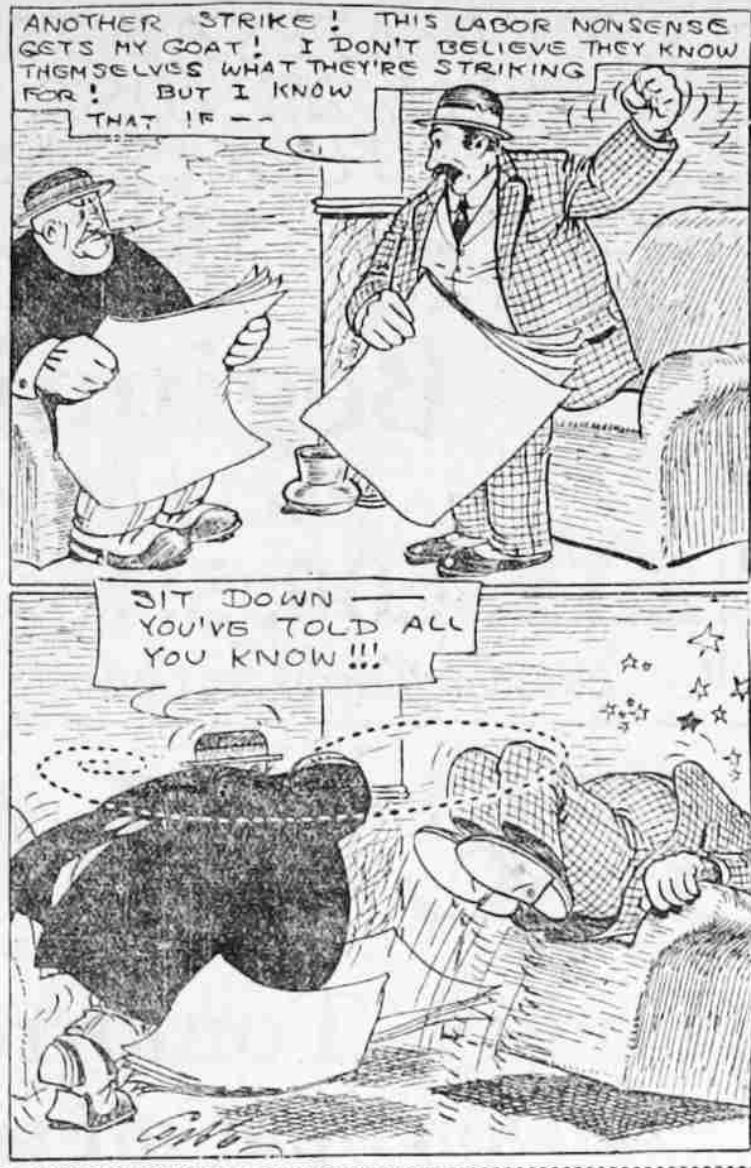


PAN MOTOR CO. FACING SERIOUS CHARGE AT TRIAL

CHICAGO, Oct. 27.—Charges of tampering with a witness for the government were made today in the trial of officials of the Pan Motor company, under indictment for using the mails to defraud in the sale of the corporation's stock to the public. Mr. Sarah E. Clark, who purchased \$200 worth of the company's stock, testified that after she had been subpoenaed as a witness for the government, Miss Florence Coleman visited her at her home at Belen, N. M., and gave her \$50 for use in buying a railroad ticket to enable her to visit the company's plant at St. Cloud, Minn., before going to Chicago to testify at the trial of the defendants. Mrs. Clark later returned the money and refused to make the trip.

After listening to the woman's story, Judge Landis asked: "Did any of these defendants send this woman to visit this witness?" Counsel for the defendants denied any knowledge of the alleged plot to tamper with the government's witness. Later Judge Landis ordered a subpoena issued for Miss Coleman. "It was on October 6, a few hours after I had been served with a subpoena that a woman who gave her name as Miss Florence Coleman, visited," said Mrs. Clark. "She asked me if I had bought stock in the Pan Motor company and I replied I had purchased \$200 of it. She said she had bought \$1200 worth of the stock and that we should be interested in having the company succeed. In reply to questions I told her I had been summoned as a government witness. "She said I ought to go to St. Cloud, Minn., and see with my own eyes the company's big plant before testifying in court. I said I would like to go but could not afford to. She said Mr. Randolph was very influential and might help me start a rooming house in St. Cloud. Then she gave me \$50 to enable me to go to St. Cloud. She stayed at my house two days, going to the de-

SALE OF SUGAR TO FRANCE BEING ROUNDLY SCORED

WASHINGTON, Oct. 27.—Action of the war department in selling to France 22,000,000 pounds of sugar sent overseas for the American expeditionary force was criticized in the house today by Representative Bland, Republican, Indiana. Mr. Bland said that since this sugar was sold, the department had called on the sugar equalization board for twelve million pounds of sugar for the army for the present quarter. "Wouldn't General Pershing know something about the disposition of American sugar in France?" asked Representative May, Democrat, Utah. "If General Pershing didn't know more about disposition of sugar than he did about the front," Bland replied, "it would be useless to ask him. I found him 200 miles from the front on July 19, 1918, when the battle of Chateau Thierry was at its height."

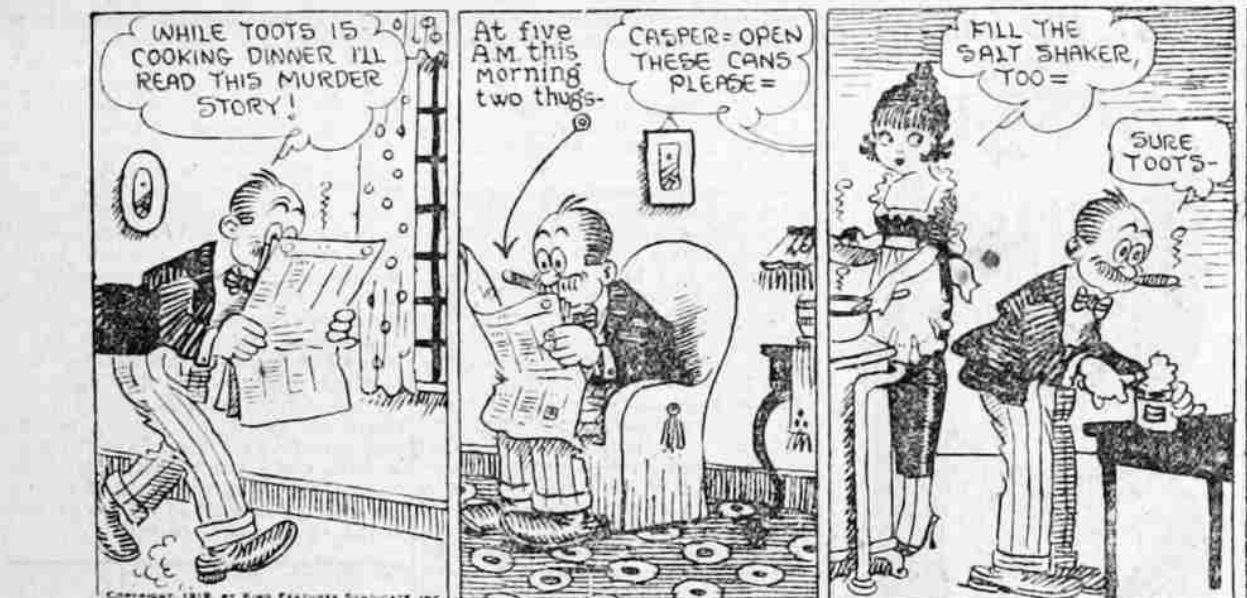

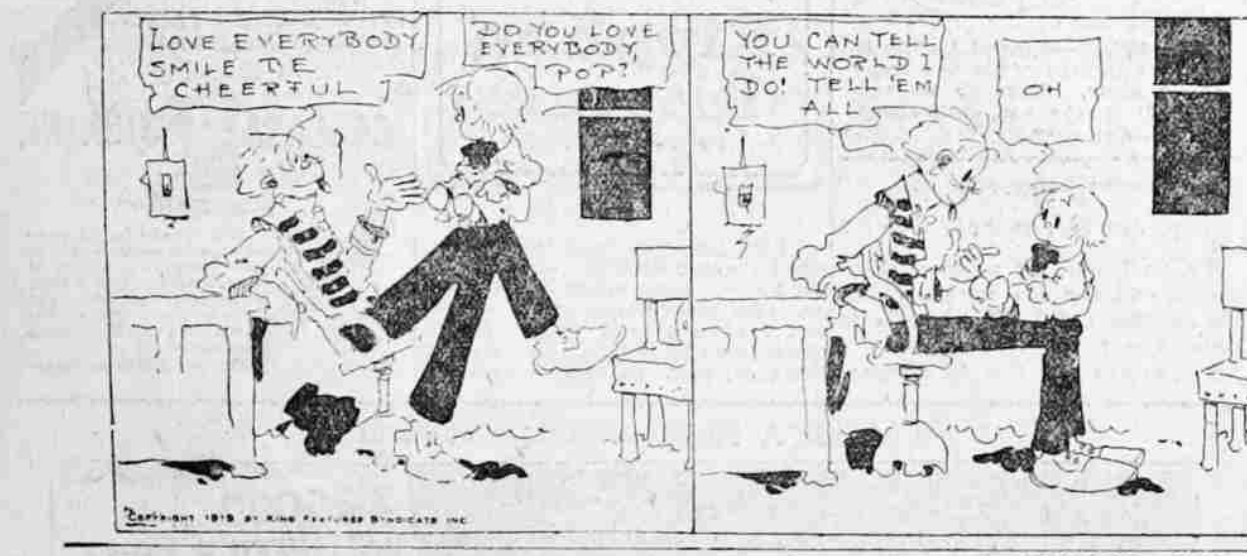

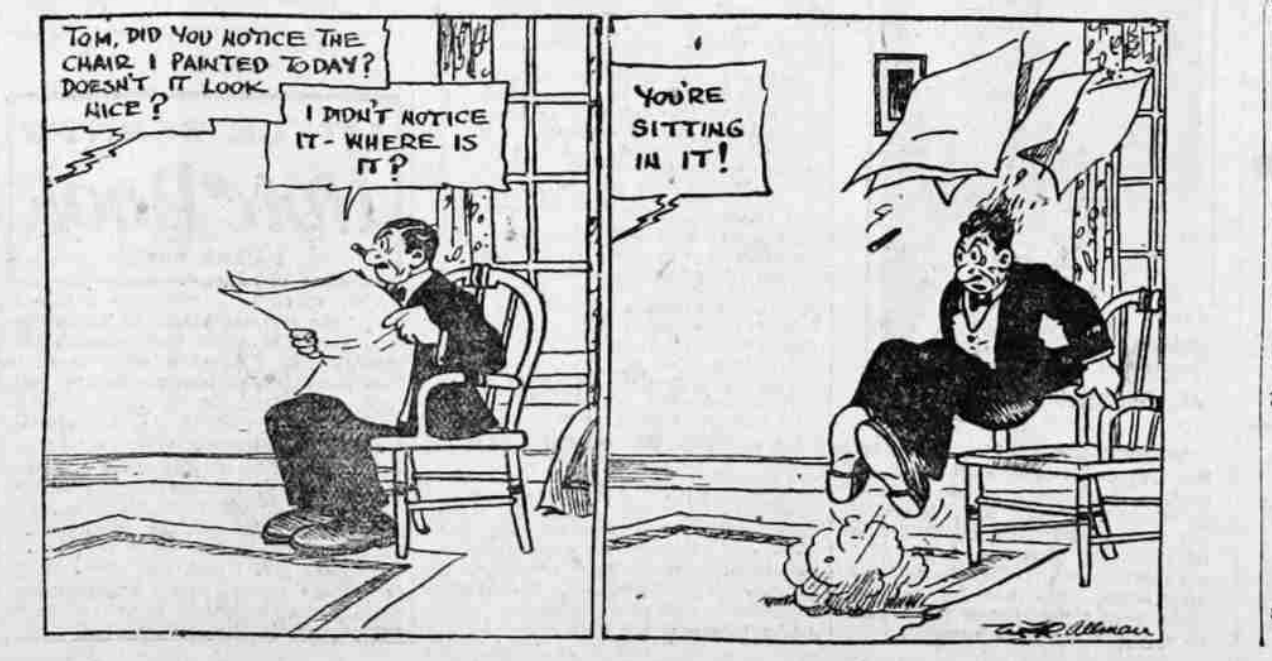
