

MEXICO OPPOSES FOREIGN OIL LINE

Pipe System Over Isthmus to Pacific Planned by Big Concerns

MEXICO CITY, Nov. 17.—Exclusion of foreign powers from direct participation in the operation of the proposed oil pipe line across the Isthmus of Tehuantepec was recommended yesterday in a report by a committee of experts appointed some time ago to study the matter. The committee also urged that foreign warships be prohibited from using any oil products flowing through such a pipe line.

Three petitions asking for concessions to lay the line were examined by the committee. One was from the Mexican Pipe Line company, which several days ago was characterized by the newspaper Excelsior as a concern primarily organized by the United States shipping board to facilitate the transportation of oil supplies from Gulf ports to American vessels in the Pacific. The other two were from the El Guila company, a concern in which British and Mexican capital is invested. It is asserted, however, to have Japanese backing.

The committee did not recommend which petition should be granted, but stipulated the concession should go to a company which is legally Mexican in make-up and which gives guarantees to abide by the laws governing such enterprises. Strong recommendation also was made that if any of the aforesaid companies must not constitute a monopoly. The department of petroleum has not indicated its attitude toward the committee's report.

VANDERLIP GETS BIG RUSS TRACT

Agent of Western Syndicate Denies Acting as Envoy For Harding

STOCKHOLM, Nov. 17.—W. D. Vanderlip, of California, who has been in Russia seeking concessions for a treaty syndicate and has recently arrived here, issued a statement Tuesday denying the intimation that he had been in Moscow at the instigation of Senator W. G. Harding in an endeavor to bring about recognition of Russia by the United States.

"I came to Russia for commercial purposes," he declared, "and I have succeeded in my efforts."

Mr. Vanderlip announced that he has leased for sixty years in behalf of the syndicate 400,000 square miles of Russian territory and that he has made other extensive contracts. With respect to these, he says:

"I have obtained an agreement whereby the Russian government will purchase in America in three years \$2,000,000,000 worth of merchandise, offering in payment therefor gold, platinum, fur, oil, products, manganese, copper, timber, pulp wood, flax, hides, grain and other raw materials, great quantities of which are ready for immediate shipment. Preference is to be given to the ships of the American merchant marine."

Mr. Vanderlip asserts that within a few months the conditions in the Far East will be returning to normal and that goods purchased in America will move freely from all Pacific coast ports over the Chinese, Eastern and Siberian railroads as well as to the Baltic ports.

'STRIKING' STUDENTS OF ST. JOHN'S WILL RETURN

ANNAPOLIS, Md., Nov. 17.—Following the action Tuesday in Baltimore of the committee of the striking four hundred students of St. John's Military college in accepting Governor Ritchie's suggestion to return unconditionally to their studies, the board of visitors of the college last night after a lengthy session adopted this resolution:

"That all students who have not signed to return by Monday, November 22, at 2 p. m., will be dismissed from the college and if any of the students so dismissed hold scholarships the acting president is directed to notify proper authorities of the vacancies so existing in order that they may be properly filled. The faculty of the college is directed by order of the board to fix such period of probation and enforce such discipline as it may deem fit."

Some of the students returned to Annapolis last night.

WIFE SHOT BY STRIKE GUARD; MATE LOSES SUIT

BOSTON, Nov. 17.—A jury in the federal court Tuesday found a verdict for the defendant in a \$10,000 suit brought by John Houtale against the United States steel corporation for the death of his wife, who was shot by guards in a strike disturbance at the Carnegie plant of the corporation in New Castle, Pa., last fall.

The suit contended that the shooting occurred while his wife was walking with him on the street near the Carnegie plant. Counsel for the defendant admitted that Mrs. Houtale was one of the strikers and that the guards were acting as protectors of the company's property when she was shot.

HOTEL OWNERS OF WEST MEET IN SANTA BARBARA

SANTA BARBARA, Cal., Nov. 17.—One hundred twenty-five hotel, railroad and steamship representatives arrived here Tuesday to attend the three days' meeting of the Western Hotels and Steamship Association, an organization of hotel men of California, Arizona, Colorado, Idaho, Montana, Nevada, New Mexico, Oregon, Utah, Washington and Wyoming, which is held annually.

The meeting has been called to formulate and discuss plans to secure federal appropriations to encourage travel in America; for federal, state, county and city governmental appropriations for the construction of highways from national park to national park; for the establishment of summer automobile camps; and for the development of community advertising by states, counties and cities.

IDAHO STUDENT JUDGES WIN AT LIVESTOCK SHOW

PORTLAND, Ore., Nov. 17.—The University of Idaho college of agriculture won first place in the student stock judging contest held on the opening day of the Pacific International Livestock exposition.

Idaho state college was second, and Oregon Agricultural college and Washington State college tied for third. Judgment was passed on eleven classes of stock, while the students were asked to give reasons for their decision on eight classes. The winning Idaho team men were Leon B. Taylor, Teuben Johnson, James Fox, William Pecharne and L. W. Kitch.

DOMESTIC WINS VERDICT FOR 12 YEARS' SERVICE

SPOKANE, Wash., Nov. 17.—Compensation for twelve years' service as a domestic was set at \$4200 here today in the superior court when Elizabeth Rounds was awarded that sum in a suit against Minnie E. Galbreath. Mrs. Galbreath since she came here from Scotland at the age of 18 years, Mrs. Rounds contended Miss Rounds had agreed to work for her room and board.

MILLIONAIRE AND WIFE GET ABSOLUTE DIVORCE

CHICAGO, Nov. 17.—The suit for separate maintenance of Mrs. Ethel Piza Crane against Herbert P. Crane, Chicago millionaire, was ended Tuesday when Mr. Crane agreed to a settlement of \$100,000 and Mrs. Crane agreed to an absolute divorce.

The divorce decree was signed Tuesday by Judge C. F. Irwin who conducted the trial at Geneva, Ill. Mrs. Crane had demurred at an absolute divorce for religious reasons. In addition to the cash settlement, she obtained custody of her 2-year-old son.



TELLS MINISTER TO GET JOB AND QUIT THE PULPIT

CLEVELAND, O., Nov. 17.—It is extreme cruelty for a minister to remain in his pulpit at \$24 a month when he has a wife and five children to support, Common Pleas Judge Frank C. Phillips declared in an opinion given in a divorce suit filed by Rev. H. A. Sherwin against his wife Tuesday.

Judge Phillips refused to grant Rev. Sherwin a divorce and ordered that he pay his wife \$50 a month alimony. Custody of their five children was given to Mrs. Sherwin.

"I consider it extreme cruelty for a man with a wife and five children to remain at his job, even though it be that of a minister, which pays only \$24 a month. An able bodied man such as you are should have taken up some other profession," Judge Phillips declared.

Sherwin now has obtained employment as a machinist.

ANACONDA GIRL KILLED; SLAYER TAKES OWN LIFE

ANACONDA, Mont., Nov. 17.—Thomas Marron last night shot and killed a school teacher here, and after firing a shot at the girl's mother drew a bottle of poison from his pocket, swallowed the contents and died almost instantly, according to the police.

Marron called at the Deet home early in the evening and was received by Miss Deet. Her mother in an adjoining room, heard a scream and then a shot. When she reached the room her daughter was lying on the floor dead. As she entered Marron fired a shot in her direction, but it went wide of the mark. Marron then swallowed the poison.

Marron who was regarded merely as a friend of the family, had called frequently at the Deet home. The cause of the tragedy is a mystery.

FUGITIVE KICKS AGAINST PRISON AT LEAVENWORTH

CHICAGO, Nov. 17.—Unless conditions at Leavenworth penitentiary have improved since he escaped from there a year ago, William Brandon, a conscientious objector, will go on a hunger strike, he declared Tuesday following his arrest as a fugitive from justice today.

"It's getting so a conscientious objector can't make a move at that place without the other prisoners beating him up," Brandon complained in his cell at the detective bureau.

DEMOCRATIC CLUB MAKES WILSON A LIFE MEMBER

NEW YORK, Nov. 17.—President Wilson has accepted honorary life membership in the National Democratic club, following the announcement that the membership was made public today.

"It is with a sense of very deep and genuine appreciation that I accept the honor the National Democratic club has conferred upon me by electing me an honorary life member. I am proud to have the endorsement of the club's confidence and esteem."

WISCONSIN LAD KILLS MOTHER BEAR AND CUBS

MARINETTE, Wis., Nov. 17.—Albert Fournay, 29 years old, of White Rapids, shot four bears yesterday. While hunting he discovered a cub in what proved to be a winter den. He shot the cub and brought the mother charging down upon him. Fournay then dispatched her and the two remaining cubs. Father bruin escaped by flight.

FOOT OF SNOW HALTS ALL BUFFALO TRAFFIC

BUFFALO, N. Y., Nov. 17.—Buffalo is snowbound today in one of the worst November storms in its history. From 4 a. m. to 7 a. m. more than a foot of snow fell. Local and interurban traffic was paralyzed. Hundreds of people walked to their work while thousands remained at home.

NEW YORK, Nov. 17.—Edward Horemans, Belgian billiardist, arrived here today on the steamer Nieme Amsterdams from Rotterdam. He is here for the purpose of getting a match for the world's professional billiard championship which Willie Hoppe has held for nearly 15 years.

DECLINES OFFER

PORTLAND, Ore., Nov. 17.—Walter McCredie, manager of the Portland Pacific Coast league baseball team, who returned here today from Kansas City, where he attended the meeting of the minor leagues, said he had been offered the position of manager of the Seattle team next year. He said the offer was attractive but he had not yet accepted. The offer, he said, was open until January 1.

GERMAN MERCHANTS VISIT JAPAN TO SOLICIT TRADE

WASHINGTON, Nov. 17.—More than sixty German merchants have arrived recently in Japan to solicit trade, according to advices to the department of commerce from Kioto. They met with little hostility, it was said, anti-foreign feeling being confined largely to Tokio and Yokohama. Readjustments incident to the war have so affected the cost of industrial production in Japan that "it is a question whether production costs in Japan will be lower than in America" when conditions settle down, recent trade messages from the Far East declare. Japanese cotton mills are resorting to the expedient of importing Korean labor and establishing plants in Manchuria. Korea and China to meet the situation, the messages state.

The Japanese rice crop has been forecast at more than 25,000,000 bushels for this year, an increase of about 12 per cent over normal. The general business situation, however, is not encouraging. It was stated, a period of general depression being expected.

FRESNO MEN REPORTED RELEASED BY FRENCH

FRESNO, Cal., Nov. 17.—Captain John A. Shismannian of Fresno, reported to have been hanged by the French, has been released and is safe in Damascus, according to a special dispatch by the Fresno Republic from the headquarters of the Near East relief in New York City. The Near East office reports that they have been so advised by a brother-in-law of Shismannian, residing in New York.

Shismannian was commissioner of an Armenian legion that was disbanded and disbanded by the French in Cilicia.
