

SWEETHEARTS DIE IN SUICIDE PACT

Woooster, O., November 1.—Death from strychnine poisoning was the verdict of coroner King today in the case of Miss Carmen Humphrey, aged nineteen years, and Rufus Billard, a young dancing master, who died within a few hours of each other under circumstances indicating a suicide pact. Billard and Miss Humphrey were engaged to marry. It was shown by one of the witnesses at today's inquest that after a recent quarrel the young man told the girl that she should marry him or nobody.

Miss Humphrey died in convulsions early today at her home, 113 E. 13th St. Billard's body was found a few hours after the girl's death in the city cemetery. He had left a note to his mother asking forgiveness, and requesting that he and Miss Humphrey be buried together and that his body be placed in the same grave.

FATAL SEALING RAID

Russian Killed and Fifteen Japanese Are Captured. Victoria, B. C., November 1.—News of a fatal sealing raid at the Copper Islands by the Japanese sealers has been received here. The Japanese schooners Boko Maru, Chitose Maru and Toyoi Maru anchored off the seal rookery in a mist. The Russian patrol cruiser arrived and they all weighed anchor and ran, leaving their small boats, which had been hauled up on the beach, while their crews were killing seals. There were five boats on shore and some of the raiders opened fire on the Russian rookery guards. Several sealers were wounded and an armed party from the patrol cruiser landed after the Russian sealers fled. The Japanese sealers fled in a panic and the Russian patrol cruiser captured the Boko Maru and the Chitose Maru. The sealers were taken to Vladivostok.

MRS. MARIE B. MANTELL DEAD

Wife of Actor, and Co-Star With Him, Victim of Heart Failure. Atlantic Highlands, N. J., November 1.—Mrs. Marie Booth Mantell, wife of Robert C. Mantell, the actor, and herself famous as a comedienne on the stage, died at her summer home here, Bracewood, Mr. Mantell was newly married to the widow of a wealthy man, and she had just returned to her home here after a visit to her husband in the city. She had been ill for some time, and her death was due to heart failure.

UNCLE SAM IN ROLE OF GREAT MERCHANT

He Buys and Sells Billions of Dollars Worth of Stuff Each Year—Usually Puts Everyone Else in Background.

(Special to The Times-Dispatch.) Washington, November 1.—Uncle Sam is a big trader. He never operates on a small scale, but, on the contrary, he buys and sells billions of dollars worth of stuff every year. When he closes his books the first of July each year and begins business over again, it is generally shown that he has put every one else in the background.

The exports of domestic farm products in 1910, valued at \$71,000,000, were smaller than in any fiscal year since 1905. The average yearly exports of domestic farm products during the five-year period of 1906-10 were greater in value than during each preceding five year period, and amounted to \$74,000,000, an increase of \$9,000,000 over the preceding five-year average.

The average exports of domestic forest products in 1910 exceeded those for each previous five-year period, and with one exception, 1861-65, show a gradual increase from \$6,000,000 in the average for 1861-65 to nearly \$4,000,000 for 1906-10.

Exports of domestic farm products consigned to Europe in 1910 were valued at \$11,000,000, a decrease of \$1,000,000, compared with the preceding year, and \$14,000,000 compared with 1908. These decreases were mostly due to a falling off in consignments of cattle, wheat, wheat flour, fresh beef, bacon, hams and pickled pork to the United Kingdom; and in exports of wheat to Canada, corn and wheat to Mexico, and lard to Cuba. In 1910, 29 per cent of the exports of domestic farm products were consigned to Europe, and 87 per cent in 1908 and 1909; and this same grand division received 57 per cent of the domestic forest products exported in 1910 and 69 per cent in 1908 and 1909.

Exports of domestic cotton increased in value from \$41,000,000 in 1909 to \$45,000,000 in 1910, due to an increase in the average export value of upland cotton from 9.4 per cent per pound in 1909 to 14.0 cents in 1910, while the quantity decreased more than one-fourth in 1910 as compared with 1909. Fruits increased from \$14,000,000 in 1908 to \$15,000,000 in 1909, and to nearly \$19,000,000 in 1910. Oil cake and oil cake meal and vegetable oils each decreased about \$7,000,000 in 1910, as compared with 1909; these two decreases were caused principally by a falling off in consignments of cottonseed oil to France, Germany, Italy and the Netherlands. The most important decreases were exports of food products.

RAISINS IN PLACE OF TOBACCO

Dr. D. K. Pearsons, Aged Ninety-One, Also Eats Peppermint Candy. Chicago, November 1.—Raisins and peppermint candy are the substitutes for tobacco in the case of Dr. D. K. Pearsons, of Hinsdale, the ninety-one-year-old philanthropist who has given all his wealth to charity and is living in a sanatorium which he founded and endowed.

Dr. Pearsons had used tobacco seventy years, but four weeks ago he "swore off" chewing and smoking, and says the raisins and peppermint candy have proved ample substitutes.

Red Hat for Almaraz. Rome, November 1.—It is stated that the Pope intends to create Archbishops de Almaraz, of Sevilla, a cardinal. Thus the foreign and Italian cardinals will be almost equal in number. The probability of the election of a foreign Pope is increasing, and the chances are said to favor America.

REPORT OF JURY IS SENSATIONAL

Birmingham, Ala., November 1.—The most sensational grand jury report in many years was submitted to the Jefferson county criminal court here today, and while thirty-five indictments were returned, the names of none of the men involved had been made public to-night, pending the service of papers.

The report alleges on recent allegations that certain office-holders have influenced corporations to head back their tax assessments until the officials proceed against them and get commissions for such extra work. It is also charged in the report that 2,482 registered voters in the county are disqualified, and it binds that many illegal votes were cast in recent elections. The report also charges a "disgrace to civilization" and accuses the justice of the peace system of the county as an "outrage."

CLAIMS THIRD OF ESTATE

Charlottesville Doctor Brings Suit to Break Wife's Will. Duluth, Minn., Nov. 1.—Dr. Frederick Oswald, of Charlottesville, Va., and a resident for the past year of Washington, arrived for the trial of a suit to break his wife's will. Mrs. Oswald bequeathed \$25,000 cash and an annuity of \$10,000 to the doctor, and left the balance of her estate, valued at nearly \$200,000, to her two children.

Dr. Oswald claims his statutory rights to one-third of the estate, despite the codicil, which specifically deprives him of the legacy if he should contest the will.

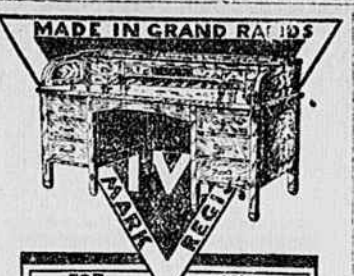

TRIAL OF ANARCHISTS RESULTS IN A FARCE

Accused of Arresting Government Agents and Holding Them as Spies. Paris, November 1.—The trial of six revolutionary anarchists accused of violation of domicile and illegal detention of citizens of the republic resulted in a farce. The accused acted as a kind of secret police for the General Confederation of Labor, and constituted at the same time a sort of revolutionary tribunal before whom were tried members of the confederation who were suspected of treachery. The actual charge against the prisoners, one of whom is on the staff of the revolutionary newspaper, the Guerre Sociale, was that they arrested with violence three persons whom they believed to be in the pay of the police, and proceeded to lock them up and force them to confess to further violence to confess their double dealing. The prisoners were acquitted.

The acquittal was chiefly attributable to the cleverness of one of the prisoners, Almeréya, who conducted his own defense, and who managed to gain the sympathy both of the public and of the jury by his exposition of the admirable methods of Almeréya and the two other government spies who were stated to have been utilized by the prisoner in order to extort confessions from them.

Almeréya is himself a "militant" revolutionary, who daily advocates measures of violence against the present "bourgeois" regime in his news paper. The leading socialist journal of Paris, the Humanité, hails the acquittal of Almeréya and his colleagues with the heading, "Acquittal of the Agents of the Commune of Clemenceau, Briand and Their Agents Provocateurs." The Temps warns the public that it will be quite mistaken if it attributes the majority of the acts against society which have been so common of late years to the instigation of "agents provocateurs," and that to say that the government encourages its agents to go to extremes is a grave exaggeration. The reason why these spies resort to violent action is that otherwise they would at once be regarded with suspicion in the circles in which they are employed.

Colonies Centre of Infection

Rome, November 1.—Italy's two chief colonies for prisoners of war, Trent Islands and Ustica Island, have become centres of infection requiring the enforcement of rigorous and hygienic measures. The telegram was dated October 25, and said: "I reached the coast accompanied by the volunteers October 25, and despite a formidable assault upon the enemy, who were driven out from their entrenched positions. Today I am marching on Tripoli. Thanks to the assistance, I shall enter the town."

Situation in Grave

London, November 2.—The Daily Mail correspondent writing from Tripoli, under date of October 27, describes the situation as extremely grave and adds that the idea that the Turks and Arabs may recapture Tripoli is not so impossible as may seem to the outside world.

WILSON FLAYS "BOSSES"

Atlantic City, N. J., November 1.—Governor Woodrow Wilson, in a speech here to-night, flayed the "bosses" of Atlantic City, saying that he would see to it that "nothing must be omitted which will clear our politics of those who do not wish to be clean." Among other things, the Governor said: "Atlantic City is famous all over the world for its charms and its sin. The whole continent looks with pity on Atlantic City because you have submitted to a system of lawless rule, coward and submissive and let it exist."

NOT UNDER PRESSURE

Former State Senator Holstlaw Made Confession Voluntarily. A. Chicago, November 1.—Attorneys A. M. Fitzgerald and George B. Gillespie, of Springfield, who acted as counsel for former State Senator Holstlaw, today told the committee of United States Senators investigating the Holstlaw case that Holstlaw's confession of corruption was made without pressure, suggestion or intimidation of any character.

The committee having charge of the fund attempted to invest it in first class securities and give the income to the widows, but the latter secured a court order requiring the distributor of the money. Yesterday an agreement was reached between the widows and the committee which will result in closing up the matter. Mrs. Margaret Horan, widow of Fire Marshal Horan, will receive \$17,000 of the fund, and Mrs. Helen Burroughs, widow of Lieutenant Burroughs, will be given \$11,000. The other widows and the two mothers will receive an average of \$5,000 each. Each one of the thirty-five children will receive about \$2,000.
