Another report came to the district attorney today that the witness had called on the day after the murder, and that he had seen the defendant in the city ever since the murder.

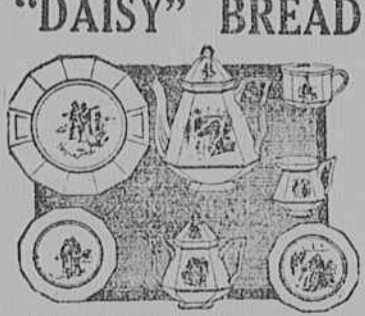
Becker's trial will begin in a few days. He is held in the city jail.

M'NEIL INDICTED BY GRAND JURY

Attack of Political Opponent Results in Criminal Libel Charge.

Fayetteville, N. C., August 29.—As the result of charges against the political and personal ability of K. Nimmo, his opponent for this Democratic senatorial nomination for the Thirtieth Senatorial District, Captain James D. McNeil was today indicted for criminal libel by the grand jury of the Criminal Court now sitting here.

The charges were contained in a circular letter distributed in Holke and Cumberland counties immediately prior to the Democratic primary in Holke last Saturday, which Captain McNeil carried.

The political charges alleged that Mr. Nimmo was "treacherous" and "dishonest" and that he had conspired with the railroad companies to defame Captain McNeil's kinman, Charles G. Rose, for the Senate nomination.

On top of this Captain McNeil received his statement in the local paper this afternoon, alleging that Nimmo had conspired with the railroad companies during the 1908 campaign to defame him in the rural districts that he represented.

In addition to denying knowledge of them, Rose in his letter to Nimmo declares that the only "treacherous methods" of which he knew in 1908 were those of Captain McNeil in organizing an opposition ticket which he ran against the Democratic county nominees.

The other charge used by McNeil concerns the settlement of an insurance partnership between Nimmo and A. J. Cook. Nimmo answers this charge by the publication in the local paper of a receipt in full settlement and satisfaction from Mr. Cook, which he claims disposes of the charge altogether.

McNeil was haled into court on the criminal libel indictments, of which there are two counts, and placed under \$500 bond on each count.

HIT BY STEAMER, COAL BARGE SINKS

Captain, His Wife and Members of Crew Have Narrow Escapes.

Newport News, Va., August 29.—While lying at anchor in Hampton Roads, one mile below Old Point, coal barge, owned by the Chesapeake and Potomac Telephone Company, was struck by the steamer Kirwood, outward bound from Norfolk.

The barge sank within fifteen minutes after the collision, having been practically cut in half.

The captain, Edward Stram, his wife and the six members of the crew barely escaped going down. They were taken aboard the Kirwood, which was badly damaged about the bow and landed here.

The steamer, leaking badly and with a heavy list to starboard, was pushed to the bank of the river by the building company, where she was put in dry-dock. Captain Nelson, of the Kirwood, states that he changed his course in avoiding another steamer and before he could again change his course, the wind and tide carried him into the barge.
