HAPPENINGS OF INTEREST FROM DIFFERENT SECTIONS

The operating revenue of the Rutland railroad for November, 1914, was \$289,724.58 and the operating expenses amounted to \$206,619.12. The operating income, \$83,105.46, showed a decrease of \$28,000.68 in comparison with November, 1913. The operating revenue for the 11 months ending Nov. 20 was \$3,272,292.75 and the expenses of operation aggregated \$2,523,694.30. The operating income amounted to \$748,598.45, which is \$70,836.95 less than for the same 11 months the previous year.

The fire loss in Rutland during 1914 was about \$75,000. The amount of insurance paid was \$16,460.08 on buildings and \$19,557.90 on personal property. In addition to the losses on which insurance was paid the Howe Scale Works factory, valued at \$40,000, on which there was no insurance, was destroyed. The firemen answered 76 alarms.

A pair of beautiful brass candlesticks has been presented All Saints' chapel in Burlington, in memory of the late William Farrar Weeks. They were made by R. Geissler of New York, and are of a special design with octagonal bases, to correspond with the brass vase.

Rev. John A. Chapin, son of Rev. D. D. Chapin of Brandon, has accepted a call to the rectorship of St. Thomas church at Dover, N. H. The church has 414 members and is the second largest Protestant Episcopal church in the state. Mr. Chapin, who for several years has been associate rector of Holy Trinity church of New York City, is a summer resident of Brandon.

DROVE BEFORE TRAIN AND STOPPED THERE

Henry W. Wilcox' Horse Seemed Paralyzed by Fear—Both Driver and Horse Were Killed.

Rutland, Jan. 13.—Henry W. Wilcox of South Main street, age 72 years, was struck and instantly killed by the Rutland railroad eastbound flyer for Boston while he was driving in a wagon across the railroad tracks at the crossing at the intersection of South Main and Park streets about 2 o'clock yesterday afternoon. Mr. Wilcox was alone in the vehicle and no one else was injured in the accident. His horse was killed. The Stearns ambulance was immediately called and the remains were taken to Mr. Stearns' undertaking rooms. Witnesses of the accident say that Mr. Wilcox drove onto the crossing without noticing the approaching train until the horn shrieking of the whistle warned him too late. His horse seemed to be paralyzed with fear and stood still directly in the path of the locomotive a moment before it bore down on the animal. One witness of the affair states that the engine struck the horse and the force of the blow threw Mr. Wilcox from his seat with such violence that he was struck from the shock when his head struck the ground.

Mr. Wilcox was born in Stockbridge, being the son of the late William B. Anna Wilcox. He was married in 1864 to Fannie White and they celebrated their golden wedding anniversary Nov. 20, 1914. Mr. Wilcox had been a farmer the greater part of his life, having also conducted a livery business for some time. He is survived by his wife and three daughters, Mrs. Frank C. Hayward and Miss Fannie C. Wilcox of Rutland, and Mrs. William Smith of Cuttingsville.

IN BOSTON MARKETS.

Butter Prices Drop One-Half Cent—Receipts of Eggs Small.

Boston, Jan. 13.—Another half cent has been lopped off local butter prices in the endeavor of the trade to stimulate the demand sufficiently to enable sales to readily be made. The cheese market is dull and no more than steady, since the supply is quite ample for wants, but the movement of eggs is a little better than it has been, and there is more steadiness to prices than there has been in the lack of really large receipts.

LIVESTOCK PRICES EASIER.

Demand at Brighton Abattoir a Little Keener—Hogs Much Lower.

Brighton, Jan. 13.—Easier prices for livestock were noted at the Brighton abattoir this morning in spite of a little keener demand for buyers. Hogs dropped one cent, owing to heavy receipts from the West. Other stock sagged off a little, though actual changes were not important.

Business at the abattoir is still being carried on under difficulties with the temporary receiving yards rigidly quarantined.  
For choice heavy cattle, eight cents was about the top price for anything offered, the range being 7 1/2 to 8 cents, with no fancy cattle noted in arrivals. Light cattle at 6 and 6 1/2 cents. Best lots brought 9 and 10 cents, mixed lots, 7 to 8 cents, grassed 5 to 6 cents and small calves 2 to 2 1/2 cents.  
Hog prices declined sharply owing to heavy arrivals at the local packing houses from western shipping points. Best lots brought 6 1/2 to 7 cents, rough lots 6 1/4 to 6 1/2 cents and hogs 5 1/2 to 6 cents.  
Sheep and lambs continue in light supply at the abattoir, but prices are easy, as values are lower. Lambs are quotable at 5 and 6 cents and sheep at 4 to 6 cents.

It is understood that the railroads are negotiating for large shipments of horses, which will be made through the stock yards, without charge.
