

A VERY PECULIAR CASE.

A North Carolina Officer Here With a Requisition.

FOR A VERY WELL KNOWN OFFICIAL.

Justice George Arkle Accused of Grand Larceny in that State—The Unusual Circumstances in the History of the Case—A Writ of Habeas Corpus will be Asked for.

There was considerable of a sensation in a limited circle yesterday over the arrival of an officer from North Carolina with a requisition from the governor of North Carolina and a warrant from Governor MacCorkle, of this state, for Squire George Arkle.

The officer who came with the papers is Neal McPhaul, of Wilmington, who weighs 295 pounds. In spite of his size, it was impossible to find him last night.

He called on Sheriff Franzheim, to whom his warrant was addressed, and a deputy went to find Squire Arkle, but failed. It was learned later that the squire and his family had driven to Moundsville for a little outing yesterday.

Colonel Arnett is the squire's attorney, and he has also consulted Prosecuting Attorney Howard in the course of the proceedings which led up to the present situation. Yesterday Judge Jordan was asked to be in his room at the court house last night, as it was desired to apply for a writ of habeas corpus. Judge Jordan came in from his home at Elm Grove, and waited until 9:30, but there was no sign of reason to ask for a writ, and he went home.

The story of the case, as related by Squire Arkle's counsel, is as follows: In 1892 he was a delegate to the supreme lodge, Knights of Honor, at Charleston, S. C. While returning, in North Carolina, Mrs. Arkle, who accompanied him, found a pocketbook in the aisle of the car, which the squire was in another car. It contained \$140 in money and \$67,000 of certificates, checks and other papers. These were, so Col. Arnett said last night, made out in favor of a man whose name seemed to be written "Masteron." It was afterwards found that his name was J. B. Mesagor, and that he was a county treasurer, living at Waterloo, N. C. Squire Arkle, after arriving home, wrote to the bank to which the papers were directed, and heard from the owner of the pocketbook.

He wrote him, offering to return the book and papers if Mesagor would consent to let him keep the \$140 in cash, and send him \$80 in bonds, making a reward of \$200 in all.

After some correspondence, Mesagor put his case in the hands of ex-Congressman A. H. Waddell, who wrote that if all the property was not returned he would have Squire Arkle indicted for larceny. Later he did so, and a requisition was sent to Governor Fleming, who refused to honor it. This was in the fall of '92. The requisition was again sent to Governor MacCorkle last year, and after some delay, he honored it and granted a warrant for Squire Arkle's arrest. This has for some unexplained reason been unexecuted ever since, and it was a general surprise when Officer McPhaul appeared here with the papers.

There are many other stories told in connection with the case, but none of them can be traced to a reliable source. Squire Arkle says that after he came into possession of the purse he laid it on the window beside his seat, so that the owner might claim it, but nobody did so, and as soon as he got home he wrote to the bank.

It is stated that McPhaul's orders from the governor of North Carolina were not to return home without his prisoner. It is probable the arrest will be made this morning, and a writ of habeas corpus be ready at once.

At an early hour this morning it was learned that McPhaul was registered at the Hotel Windsor as A. B. Jones, of Baltimore, Md., and occupied room 12. He arrived shortly after midnight yesterday morning. Last night Sheriff Franzheim called on McPhaul and promised to have Squire Arkle in custody this morning.

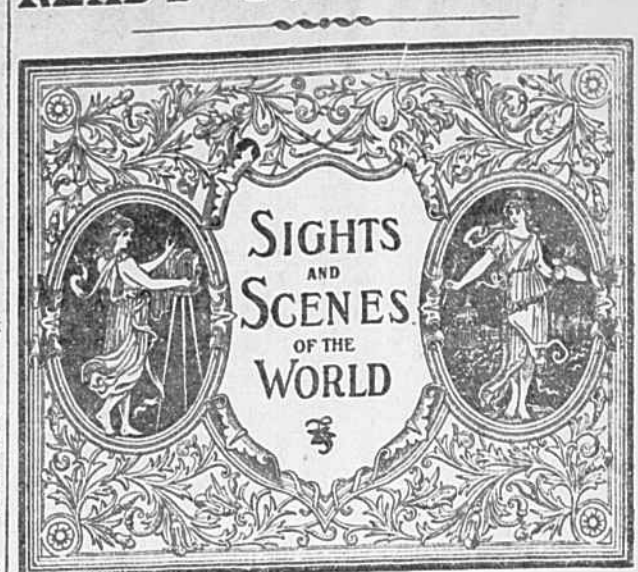
