**THE GLORIOUS**

People's Party And Whither They Are Tending.

The attempt to overthrow popular government in Kansas may be so instructive as to be set down among the blessings of this passing year. The persons who are actively engaged in it are the Governor, the representatives of the People's party in the lower house of the Legislature, some subordinate state officials who may consider themselves bound by the orders of their superiors, and an uncertain number of citizens. It is further supported by a part of the people of the State—how large a part it is impossible to say, but, as all available evidence indicates, a small minority. Against it are arrayed the lawful majority of the House of Representatives, the officers of police and militia in the capital, and a popular sentiment which is unquestionably predominant in Kansas, and in the country at large overwhelming.

If all these superior forces arrayed against the Populist revolution were united in an attempt to maintain an unlawful supremacy they might succeed, though they would not deserve to. But in reality the advantage of numerical strength is increased many fold by the righteousness of their cause, and therefore their confident expectation of victory is amply justified. Their physical superiority, indeed, is a convincing proof that they are in the right, for the forces on their side include elements which otherwise would not be found in combination. If the Governor of the State were upholding constitutional government in Kansas Colonel Hughes and his militia regiment would not have refused to obey their commander-in-chief. His attitude and orders have not obscured the fact that a clear and undisputed majority of Representatives holding official certificates of election organized the lower house of the Legislature in opposition to the Populist minority, and that everything since done or attempted by that minority has been done or attempted in defiance of law.

This experience, as we have said, may prove exceedingly valuable. The party in whose name and behalf these acts of revolution have been perpetrated is the so-called People's party.

**ITS NAME IS A FALSEHOOD.**

It claims to be the only existing agency by which liberty and justice in the United States can be saved from destruction. Its avowed mission is to expiate abuses of power; to take the Federal and State governments and all our civil institutions out of unclean hands, and to put purity and honesty everywhere in control. Through its platforms and orators it has had an infinite deal to say about the robbery and oppression of the masses, about all-pervading corruption, about bribery and intimidation of voters, about a vast conspiracy against mankind, and about the tottering fabric of freedom. And it has pledged itself to establish the reverse of all these alleged conditions. Ostensibly to this end it has proclaimed various fantastic schemes, and every policy of administration which is not in harmony therewith it has denounced as an instrument of torture, devised by thieves and tyrants to crush the toiling millions. It has given to those who exposed and resisted it no credit for patriotism or public morality of any sort, and with special zest and satisfaction has described their beliefs and actions as essentially treason to popular rights.

It is therefore, peculiarly instructive to find the representatives of this party in a great State, where it had an invaluable opportunity to vindicate its sincerity, giving the lie to all its professions and endeavoring, first by fraud and then by violence, to overrule the will of the people and supersede the fundamental law. Such a demon-

stration of hypocrisy is not likely to be overlooked or forgotten by the people of the United States.

**SLIPPERY AS AN EEL.**

The Snake That Lived for Twelve Years in a Woman's Stomach.

Rachel M. Moore is lying in a dangerous condition at her home in Millville, N. J., and is not expected to live. Her case, which is described at length by the Cincinnati Enquirer, is puzzling to a score of physicians. For twelve years she carried a snake in her stomach, and on last Sunday the reptile crawled out of her mouth. Since that time she has been daily growing weaker and refuses all solid food. The fact of Miss Moore having a snake in her stomach has been known by her friends for years. In the summer of 1880 she attended a garden

party near Cedarville, where she then resided.

The party was given on a farm, and in a spirit of fun she drank out of a bucket which was used to hoist water out of the well. She felt something slipping down her throat at the time, but forgot the occurrence until a year after, when she and her friends noticed her ravenous appetite. She always felt hungry, and ate nearly enough for two persons. She soon felt the moving of some creature within her, and the occurrence of her drinking out of the bucket at the well was remembered. Physicians were consulted, and they decided that Miss Moore's body was the dwelling place of a snake. They tried by various methods to kill the reptile, but without success. As she continued to enjoy good health, and for weeks at a time was not bothered by the creature, it was decided best to permit nature to take its course, in hopes the snake would some time come out of its own accord.

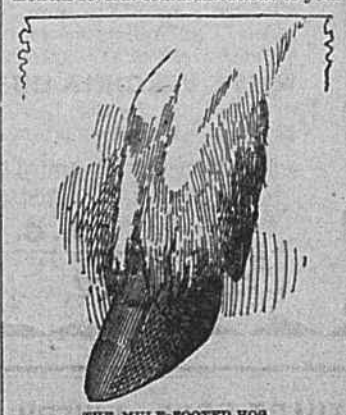
Years passed on, but the snake continued to make its abode in the young woman. Once when she ate honey it crawled up into her mouth and part way out between her lips. Its body was not more than a quarter of an inch thick, there were no eyes and the general color was green. Her mother grasped the hideous reptile and attempted to pull it out altogether, but the slimy body slipped through her hands and down the girl's throat as though it had been greased. Miss Moore frequently ate honey after that in hopes of the snake again making its appearance, but it never came up further than her mouth. A year ago while in bed she was awakened in her sleep by something cold crawling over her breast. She screamed and the snake quickly drew itself back in her mouth and down her throat.

Late Saturday night she was seized with a choking sensation, which continued periodically during the night, and early Sunday morning the snake crawled out of her mouth several inches. With great presence of mind she closed her teeth on the body of the repulsive creature and ran to her mother, who succeeded in entirely relieving her daughter of the unwelcome tenant. The snake was fifteen inches long, and died a few minutes after being in the air. Miss Moore fainted several times on Sunday, and during the night became violently ill. Her stomach refuses to hold food except in liquid form. She is 30 years old and weighs 125 pounds, and until the present time has enjoyed exceptionally good health.
